

SURVEYOR'S AFFIDAVIT

I, Frederic W. Zietlow, Registered Land Surveyor, whose place of business is at Mid-State Associates, Inc., Baraboo, Wisconsin, hereby depose and say:

That at the request of Scott Christensen, I have made necessary measurements and have examined the following description:

"That part of the N $\frac{1}{2}$ -NE $\frac{1}{4}$ of Section 8, T14N, R6E, described as:

Commencing in the center of the Plainville and Dell Prairie Road where said highway crosses the west line of the NW $\frac{1}{4}$ -NE $\frac{1}{4}$ of Section 8, T14N, R6E; thence Southeasterly following the center of said highway to an iron post in the center of said highway distant 49 rods and 6 inches from said west line of said NW $\frac{1}{4}$ -NE $\frac{1}{4}$ of Section 8, T14N, R6E, fixing the point of commencement;

thence Southeasterly in the center of said highway a distance of 1546.4 feet to a stake which is 512 feet North of the south line and 20 rods West of the east line of the N $\frac{1}{2}$ -NE $\frac{1}{4}$ of Section 8, T14N, R6E; thence due South a distance of 512 feet to the south line of the N $\frac{1}{2}$ -NE $\frac{1}{4}$ of Section 8, T14N, R6E; thence due West on the south line of said N $\frac{1}{2}$ -NE $\frac{1}{4}$ of Section 8, T14N, R6E, a distance of 1516.5 feet to a stake; thence North, var. 3° East 775 feet to the place of commencement.

EXCEPT the following: Commencing at the southeast corner of the NE $\frac{1}{4}$ -NE $\frac{1}{4}$ of Section 8, T14N, R6E; thence West 330 feet on the south line of said NE $\frac{1}{4}$ -NE $\frac{1}{4}$ to a point, the point of beginning;

thence North and parallel to the east line of Section 8 to a point in the center of the Plainville and Dell Prairie Road 536.25 feet; thence West 165 feet; thence South 536.25 feet to the south line of the NE $\frac{1}{4}$ -NE $\frac{1}{4}$ of Section 8; thence on the south line of the NE $\frac{1}{4}$ -NE $\frac{1}{4}$ 165 feet to the point of beginning.

A part of the NE $\frac{1}{4}$ -NE $\frac{1}{4}$ Section 8, T14N, R6E, as in deed recorded in Volume 122 of Deeds on Page 280.

AND FURTHER EXCEPTING: The West 290 feet of the above described land as recorded in Volume 147 of Records on Page 332.

ALL OF THE ABOVE DESCRIBED LAND being in the Town of Dell Prairie, County of Adams, State of Wisconsin."
