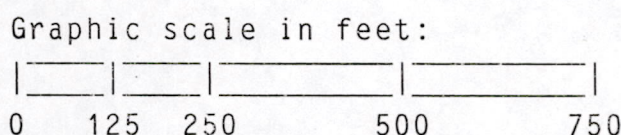
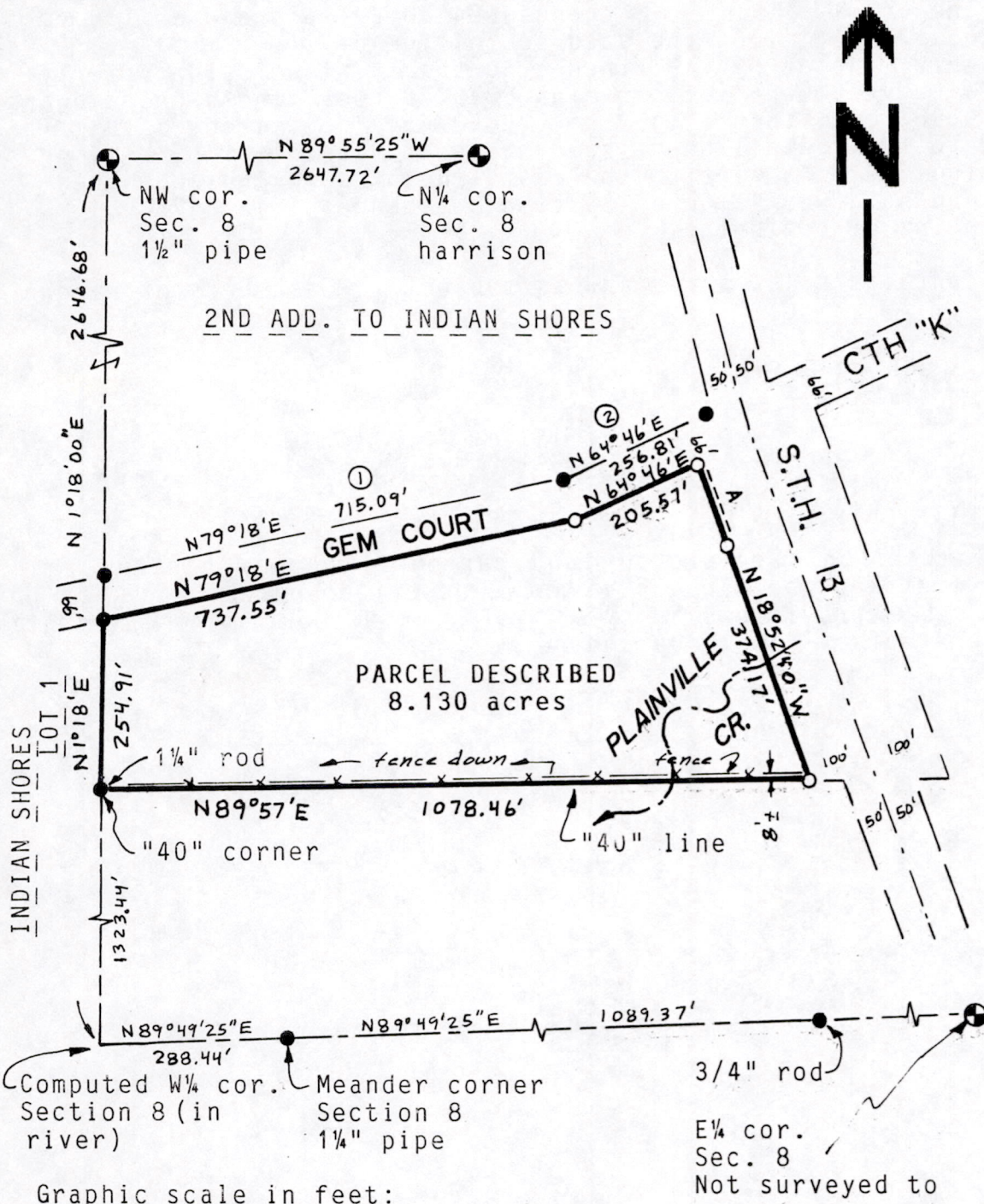


PLAT OF SURVEY

**DESCRIPTION OF HEAVY OUTLINED AREA:**

A parcel of land located in the NW¼-NW¼, Section 8, T14N, R6E, Town of Dell Prairie, Adams County, Wisconsin bounded by the following described line: Beginning at the northeast corner of Lot 1, Indian Shores Subdivision, also being on the west line of said Section 8 and the south line of Gem Court\* ; thence N79°18'E, 737.55 feet along the said south line of Gem Court ; thence N64°46'E (recorded as N64°50'E), 205.57 feet along the said south line of Gem Court to the westerly R/W line of STH 13; thence Southerly along said westerly R/W line on a curve to the left, radius 5829.70 feet, whose chord bears S18°14'E, 130.98 feet; thence S18°52'40"E, 374.17 feet along said westerly R/W to the south line of said NW¼-NW¼; thence S89°57'W along said south line, 1078.46 feet to the east line of said Indian Shores Subdivision and said west line of Section 8; thence N1°18'E, 254.91 feet to the point of beginning.

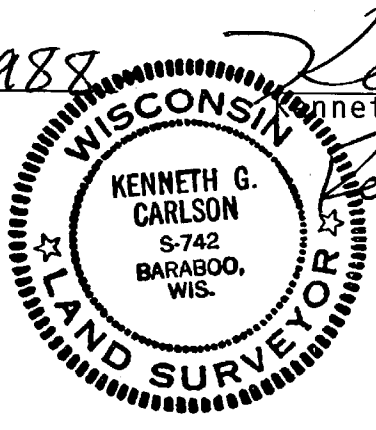
Said parcel contains 8.130 acres and is subject to easements of record.
