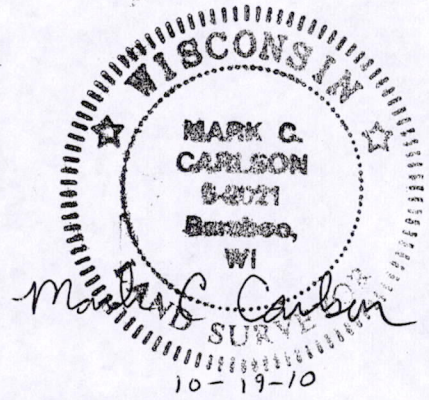

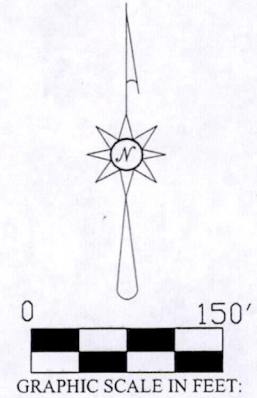
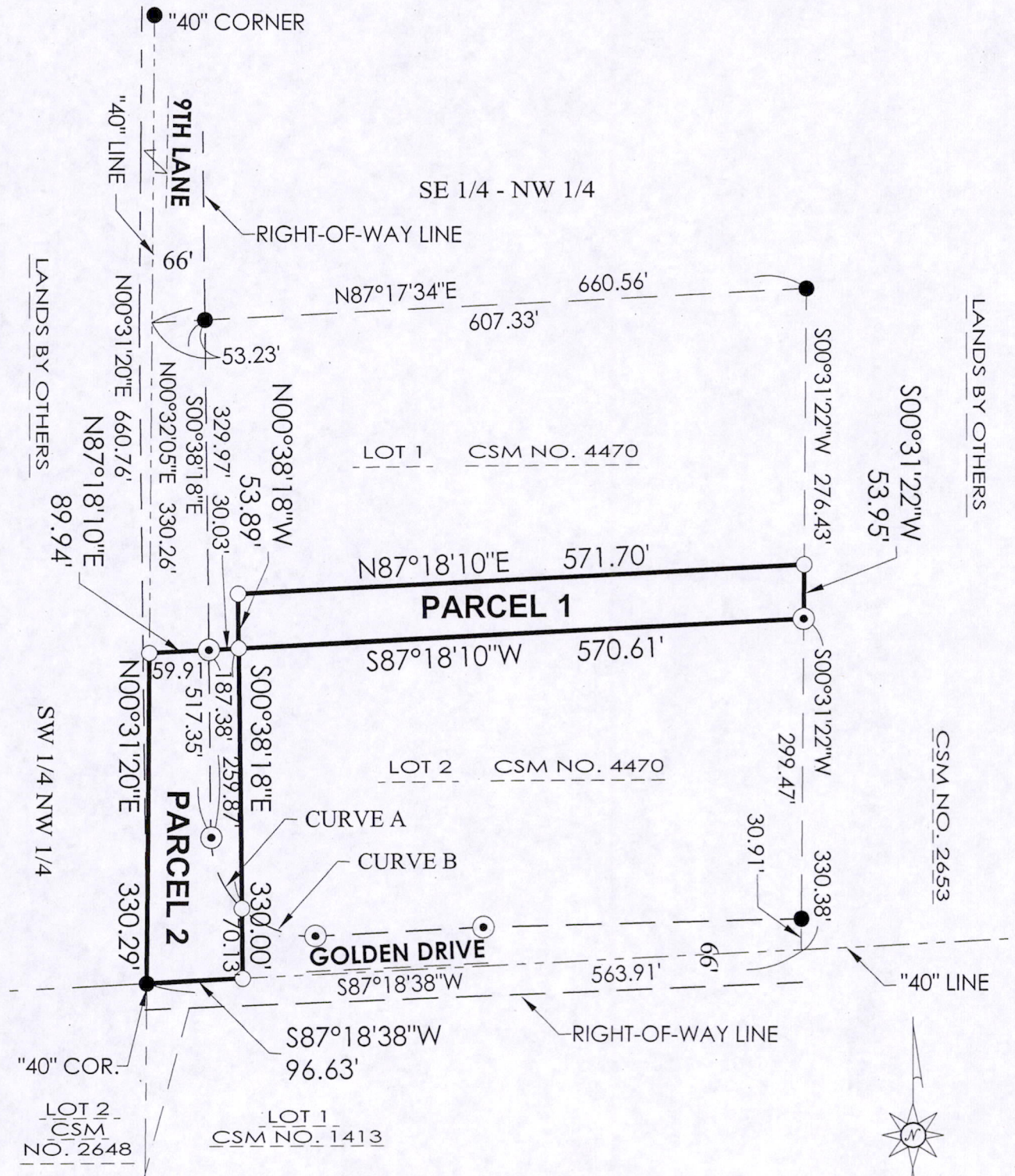

**PARCEL 1 DESCRIPTION (Chula Vista Golf Resort, Inc. to Jacobson):**

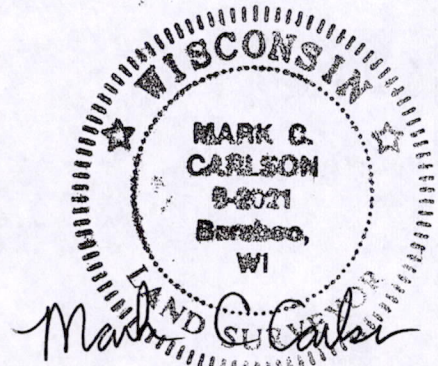

Parcel contains 30,760 square feet and is subject to easements of record.

**PARCEL 2 DESCRIPTION (Jacobson to Chula Vista Golf Resort, Inc.):**

A parcel of land located in Lot 2, CSM No. 4470, SE1/4-NW1/4, Section 27, T14N, R6E, Town of Dell Prairie, Adams County, Wisconsin bounded by the following described line: Beginning at the southwest corner of said Lot 2; thence N0°31'20"E along west line of said Lot 2, 330.29 feet to northwest corner of said Lot 2; thence N87°18'10"E along north line of said Lot 2, 89.94 feet; thence S0°38'18"E, 330.00 feet to south line of said Lot 2; thence S87°18'38"W along said south line, 96.63 feet to point of beginning. Parcel contains 30,760 square feet and is subject to highway and other easements of record.
