

PARCEL DESCRIPTION (to be attached to Chula Vista land to the south): A parcel of land located in Government Lot 5, Section 28, T14N, R6E, Town of Dell Prairie, Adams County, Wisconsin bounded by the following described line: Commencing at the northeast corner of said Section 28; thence N89°57'00"W along the section line, 2617.96 feet to the north quarter corner of said Section 28; thence S44°45'05"E, 1088.12 feet to the centerline of River Road (recorded as Highway No. 13); thence S61°18'W, 103.73 feet; thence S35°00'W, 145.83 feet; thence S65°13'W, thence S19°11'E, 65.05 feet to the point of beginning; thence N19°11'W, thence S19°11'E, 65.05 feet to the point of beginning; thence N19°11'W, thence N65°13'E, 89.66 feet; thence N35°00'E, 145.84 feet; thence N61°18'E, 103.73 feet to the centerline of River Road; thence Southerly chord bears S12°31'E, 245.08 feet; thence S18°18'E, along said centerline on a curve to the left, radius 1216.15 feet, whose 28.87 feet; thence S88°37'W, 171.10 feet (recorded as WEST, 167'10"); S88°10'W, 55.06 feet (recorded as WEST, 55 feet); thence S22°17'W, 32.34 thence Westerly along the bottom of ravine to a point that is S18°30'E quarter corner of said Section 28; thence S44°45'05"E, 1088.12 feet to thence Westerly along the bottom of ravine to a point that is \$18°30'E from the point of beginning; thence \$\text{N18°30'W}\$, \$110 feet, more or less, to the point of beginning. All lying south of the south bank of the ravine commonly known as Roodes Glen (recorded as Roods Glen).
