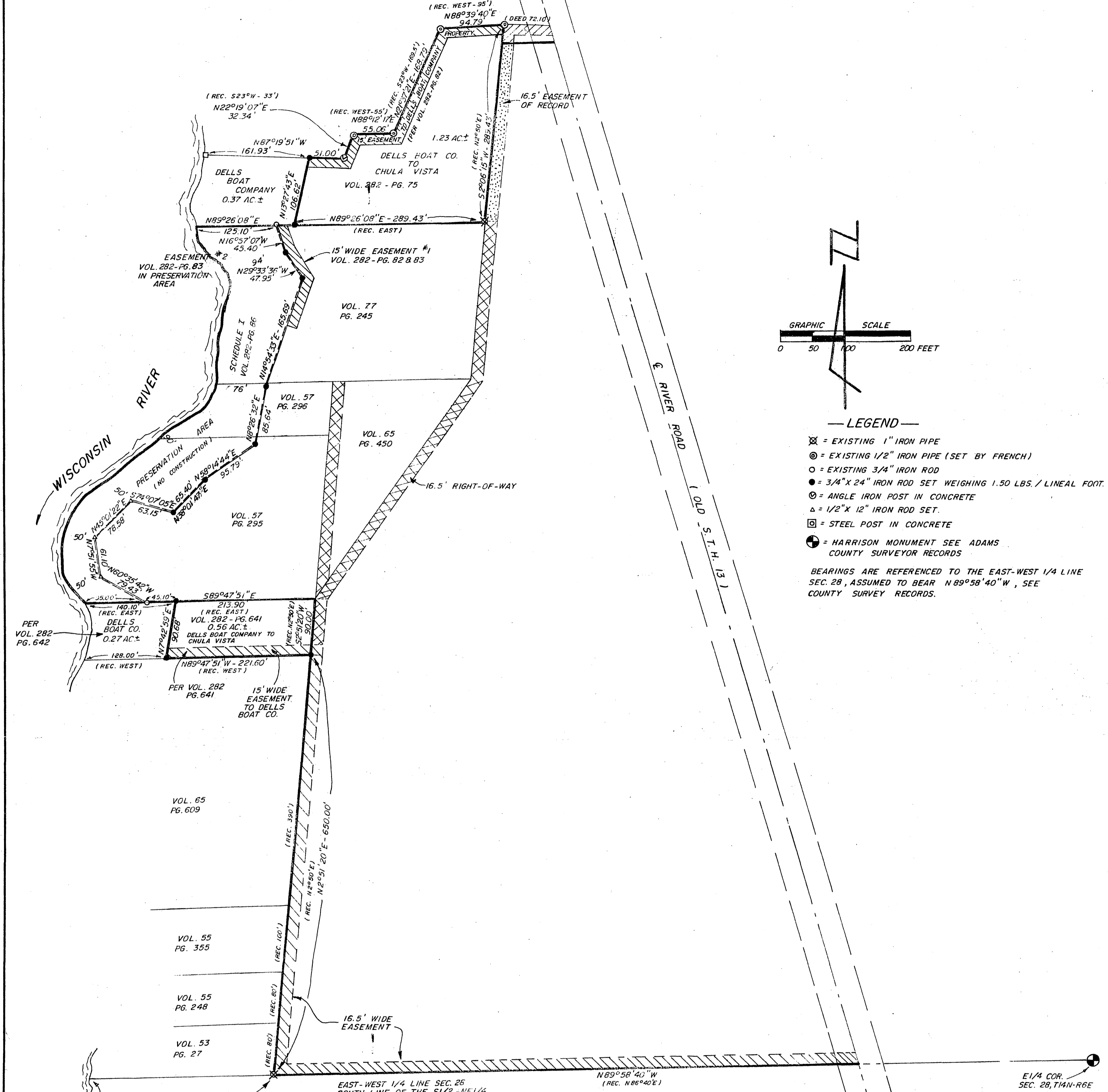
CHULA VISTA RESORT

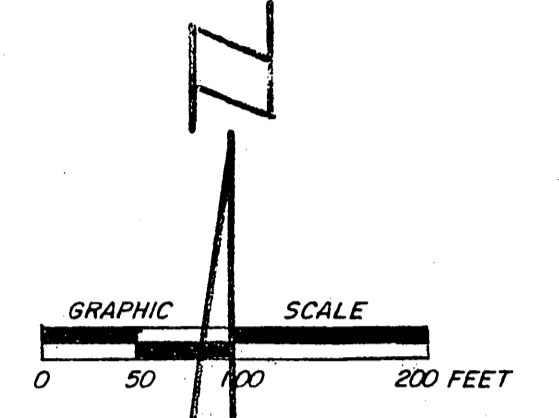
