
DESCRIPTION

A parcel of land in the Northeast Quarter of the Northeast Quarter of Section 35, Town 14 North, Range 6 East, described as follows:

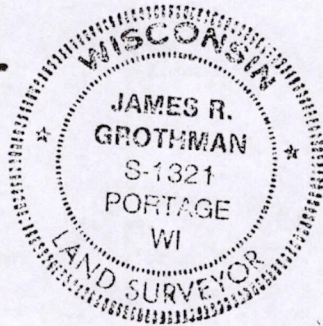
