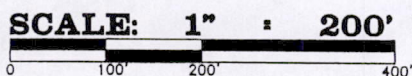

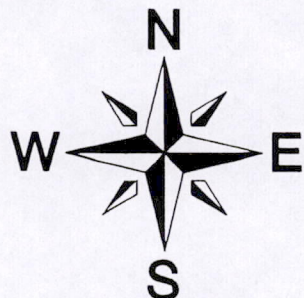
GENERAL LOCATION

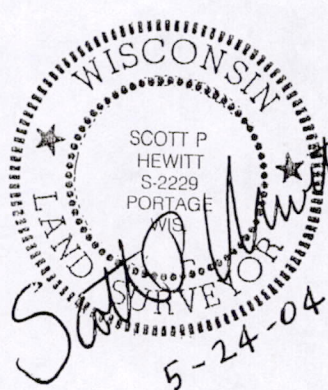
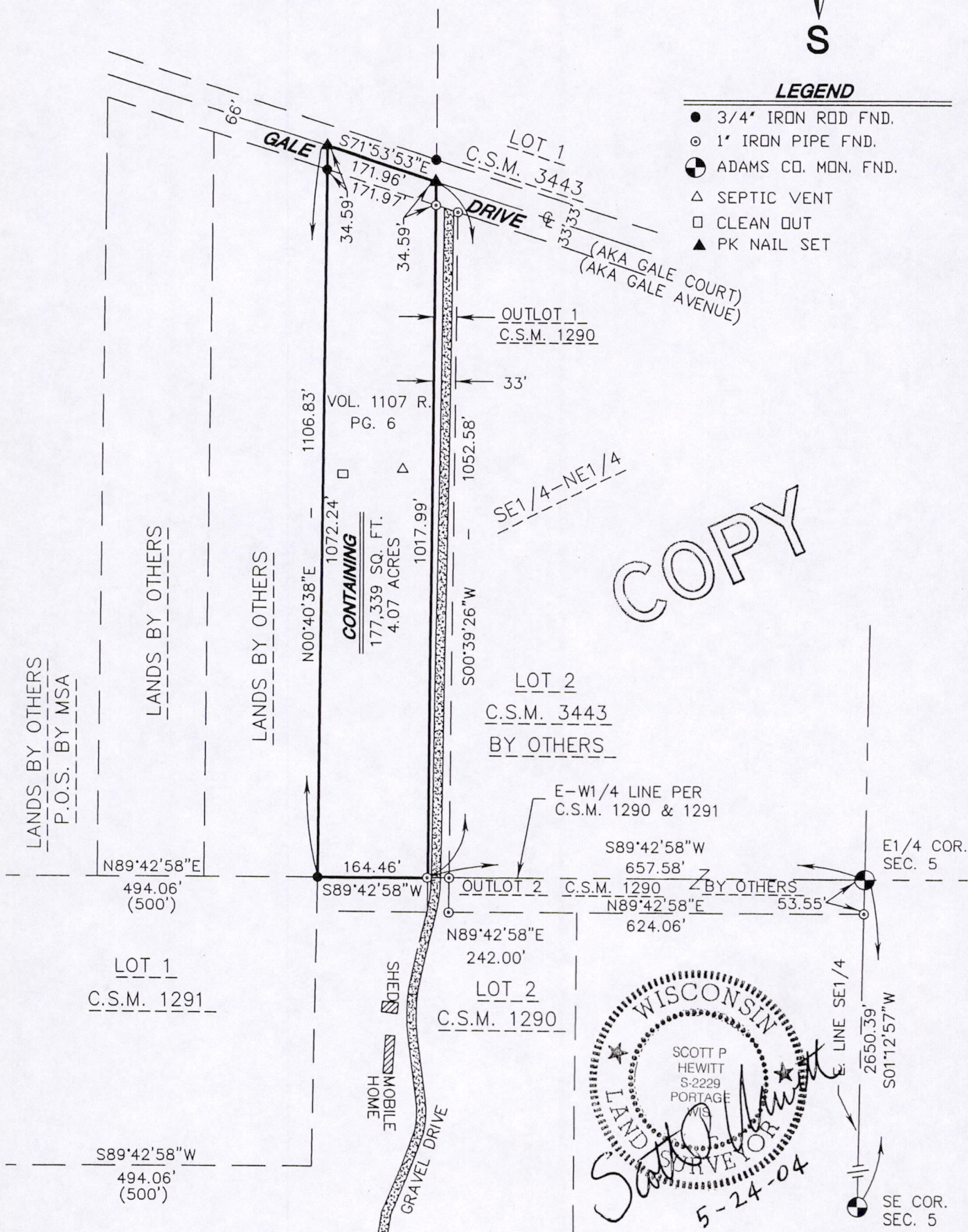
BASIS OF BEARINGS:

SURVEYOR'S CERTIFICATE

I, **SCOTT P. HEWITT**, Registered Land Surveyor, do hereby certify that by the order of **Thomas Mayer**, I have surveyed, monumented, and mapped a part of the Southeast Quarter of the Northeast Quarter of Section 5, Town 14 North, Range 7 East, Town of New Haven, Adams County, Wisconsin, described as follows:

Commencing at the east quarter corner of said Section 5;
thence South 89°42'58" West along the east – west quarter line of Section 5 and also being the southerly line of Outlot 1 and the northerly line of Outlot 2, Certified Survey Map, No. 1290, 657.58 feet to the southwest corner of said Outlot 1, Certified Survey Map, No. 1290 and the point of beginning;
thence continuing South 89°42'58" West along the east – west quarter line of Section 5, 164.46 feet to the northeast corner of Lot 1, Certified Survey Map, No. 1291;
thence North 00°40'38" East, 1,106.83 feet to a point in the center line of Gale Drive, also known as Gale Court and also known as Gale Avenue;
thence South 71°53'53" East along the center line of Gale Drive, also known as Gale Court and also known as Gale Avenue, 171.96 feet to the northwesterly corner of Lot 2, Certified Survey Map, No. 3443;
thence South 00°39'26" West along the westerly line of Outlot 1, Certified Survey Map, No. 1290 and the west line of Lot 2, Certified Survey Map, No. 3443, 1,052.58 feet to the point of beginning.
Containing 177,339 square feet, (4.07 acres), more or less. And being subject to Gale Drive right-of-way along the northerly 33 feet thereof and servitudes and easements of use or record, if any.
