
The sketch below was traced from an aerial map showing the lake and New Highway No. 23; we have spotted the description of the lands abstracted belonging to James M. Cummings and wife as nearly as we could; however, the description makes reference to County Highway "X" and it would appear that if the south Nine of the Cummings land was the north margin of County Highway "X", the new highway could possibly have been laid out south of old highway "X" and in that case, the Cummings land would not border on the new highway.
