

TOWN OF NEW HAVEN-ADAMS COUNTY

SE CORNER OF SECTION 36, TIAN RIF

A parcel of land located in the SE%-NW%, SW%-NE%, . Section 56, Tl4N, R7E, Town of New Taven, Adams County, Wisconsin, which is bounded by the following described line:

Commencing at the southeast corner said Section 36; thence Northerly along the east line said Section 36, 2146 feet to the present centerline (July 18, 1967) of STH 23; thence N83°12'W, along said centerline and centerline extended 1943.6 feet; thence N66°16'W, along said centerline extended 1184.6 feet to the point of beginning of the parcel to be

thence N15° 44'E, 811.0 feet to the north line of an East-West drive, which point is S81°32'E, 163.4 feet from the point of beginning of a parcel recorded in Volume 122, page 456; thence S81°32'E, along the north described in Volume 142, page 76; thence at right angles and N8°28'E, along said water's edge to the water's edge of Lake Mason; thence Easterly NE¼, said Section 36; thence South along said east line to the south of STH 23; thence N66°16'W, along said centerline to the point of beginning

EXCEPTING THEREFROM the aforementioned town road;
EXCEPTING THEREFROM: Commencing at the southeast corner said Section 36; thence Northerly along the east line said Section 36, 2146 feet along said centerline (July 18, 1967) of STH 23; thence N83°12'W, N66°16'W, along said centerline extended 1943.6 feet; thence thence N15°44'E, 265 feet along the centerline extended 1151.6 feet; point of beginning;

thence S15°44'W, 265 feet along said centerline to the centerline of STH 23; thence S66°16'E, 222 feet along said centerline; thence N21°45'E, 265 feet; thence N66°16'W, 250 feet to the point of beginning.

EXCEPTING THEREFROM: A parcel conveyed to Adams County for park purposes, described as follows:

Commencing at the southeast corner of the SE¼-NW¼, Section 36, Tl4N, R7E; thence running West on the south line of the SE½-NW¼ aforesaid north line of an east and west drive; thence running East on the north line of said east and west drive, 325 feet to a point hereinafter referred to as Point "A"; thence running Northerly at a right angle to low water mark on the South shore of Lake Mason and to the point of beginning;

thence running Southerly over the last mentioned course to point "A"; thence running West along the north line of the said east and west drive,

^{95.7} feet and to a point on the east line of a north and south town road; thence running Seath ray on the east line of said north and south town road 40 feet as a point; seemed running East parallel with the north line of said east-west drive, 500 feet to a point; thence running Northerly at a single seemen to the low water mark on the South shore of Lake Mason; these running Westerly at the low water mark on the South shore of lake water of the case to the raint of peginning.
