

Lots 24 and 25 of SPRINGVILLE ASSESSOR'S PLAT No. 2, Town of Springville, Adams County, Wisconsin, also described as follows;

BEGINNING at the Southwest corner of said Lot 24; thence N23°11'58"W, 324.90 feet along the west line of said Lots 24 and 25; thence N00°41'58"W, 100.00 feet to the Northwest corner of said Lot 25; thence N89°13'42"E, 350.77 feet along the north line of said Lot 25; thence continuing along the north line of said Lot 25 S54°32'00"E, 72.68 feet to the westerly right-of-way of 10th Lane; thence along said westerly right-of-way along the arc of a curve concave to the east with a radius of 238.00 feet (whose long chord bears S16°23'31"E, 338.77 feet) 376.95 feet; thence continuing along the said westerly right-of-way of 10th Lane along the arc of a curve concave to the southwest with a radius of 287.97 feet (whose long chord bears S56°17'23"E, 54.94 feet) 55.03 feet to the south line of said Lot 24; thence S89°13'42"W, 422.07 feet along the south line of said Lot 24 to the POINT OF BEGINNING.
