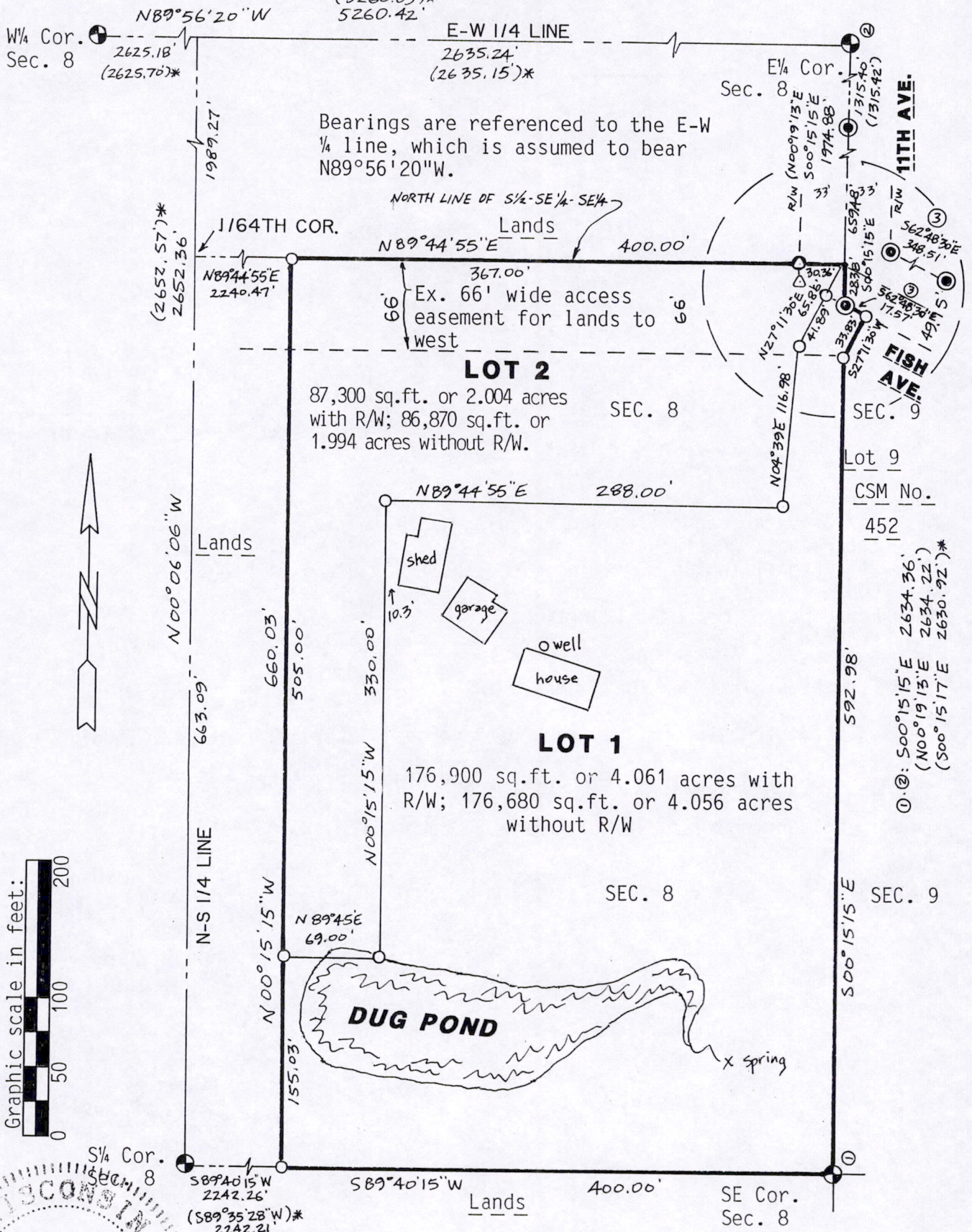


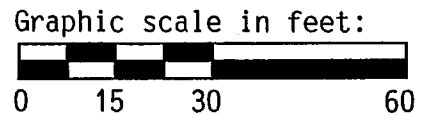
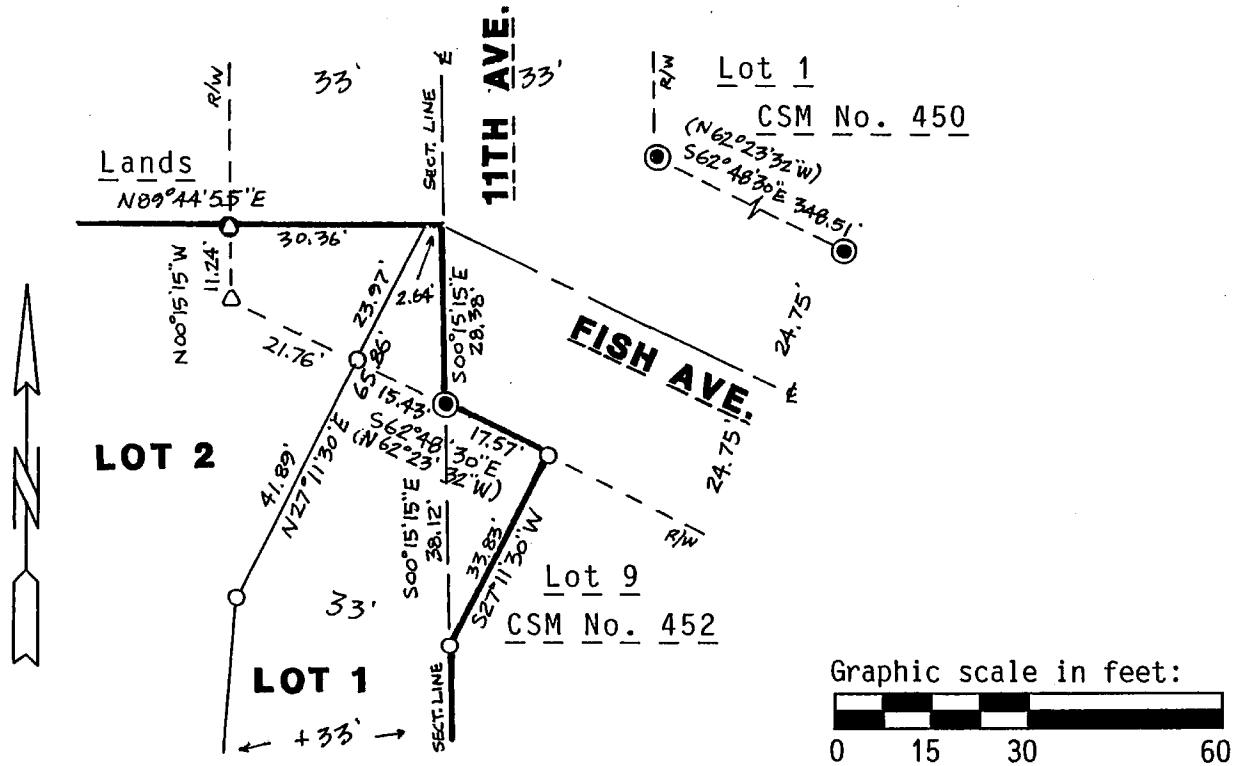
ADAMS COUNTY CERTIFIED SURVEY MAP No. **UNRECORDED**

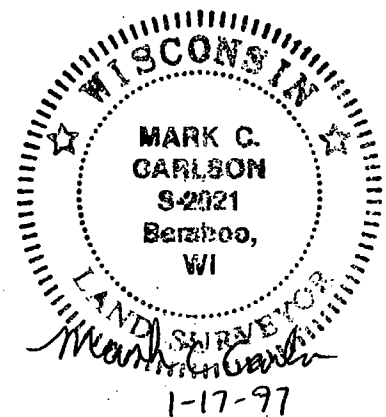

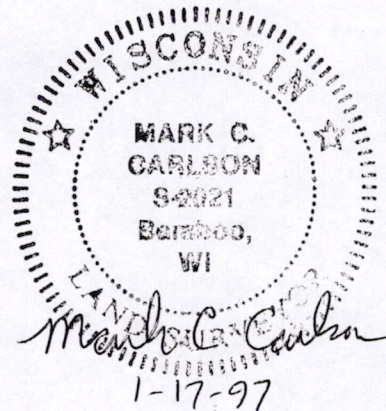
