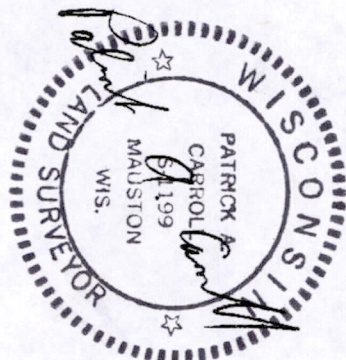
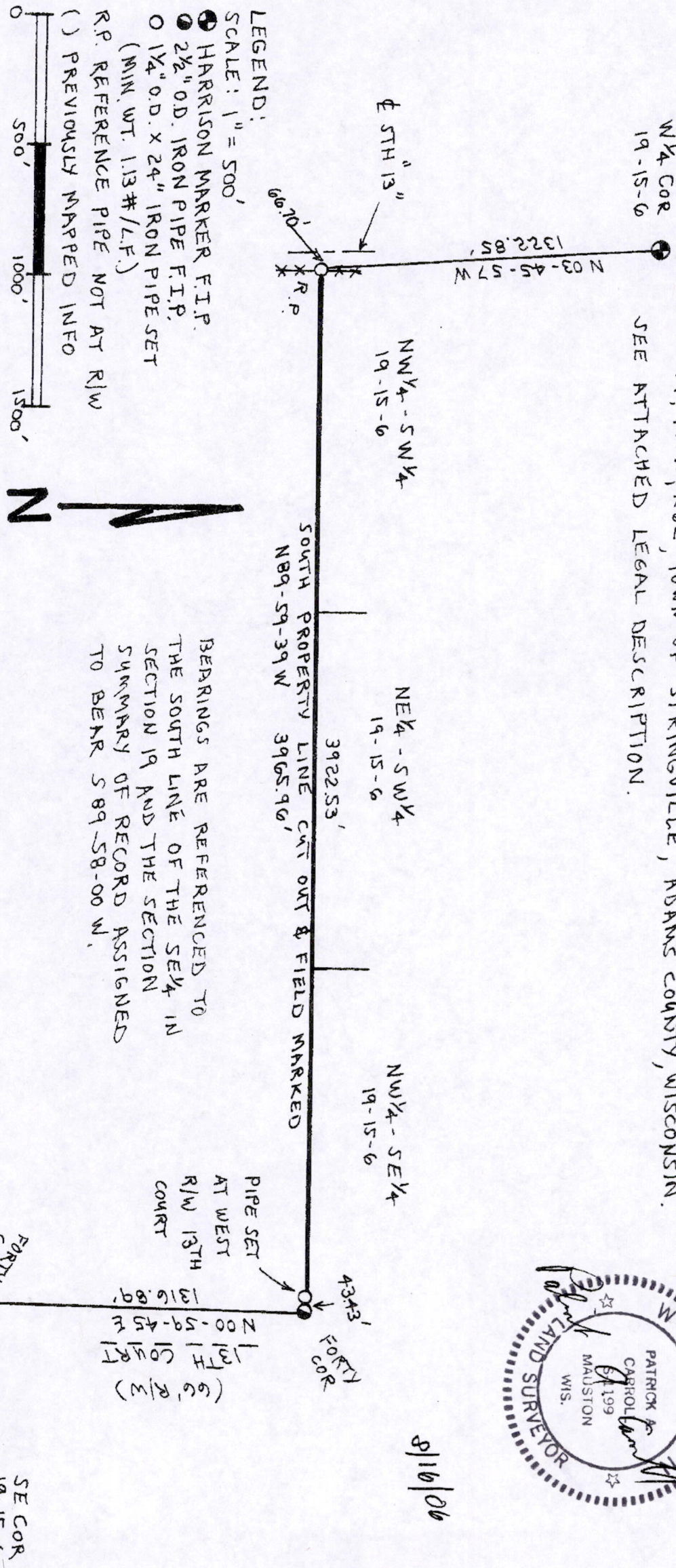


PLAT OF SURVEY - LEO VAN ERT, PROPERTY

DESCRIPTION:

PART OF THE NW1/4-SW1/4, PART OF THE NE1/4-SW1/4 AND PART OF THE NW1/4-SE1/4,
ALL IN SECTION 19, T15N, R6E, TOWN OF SPRINGVILLE, ADAMS COUNTY, WISCONSIN.

The following described property line is the south line of said forties east of STH "13" more fully described as follows:

Commencing at the SE corner of said Section 19; thence along the south line of said SE1/4 bearing S89-58-00W, 1311.90 feet, to forty corner; thence along the forty line bearing N00-59-45E, 1316.89 feet, to forty corner, being the point of beginning. Thence bearing N89-59-39W, 3965.96 feet, to the point of termination.
