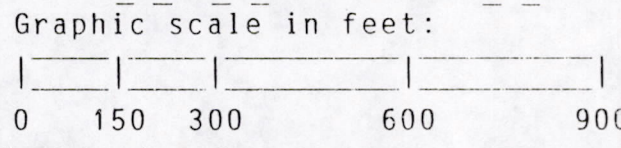
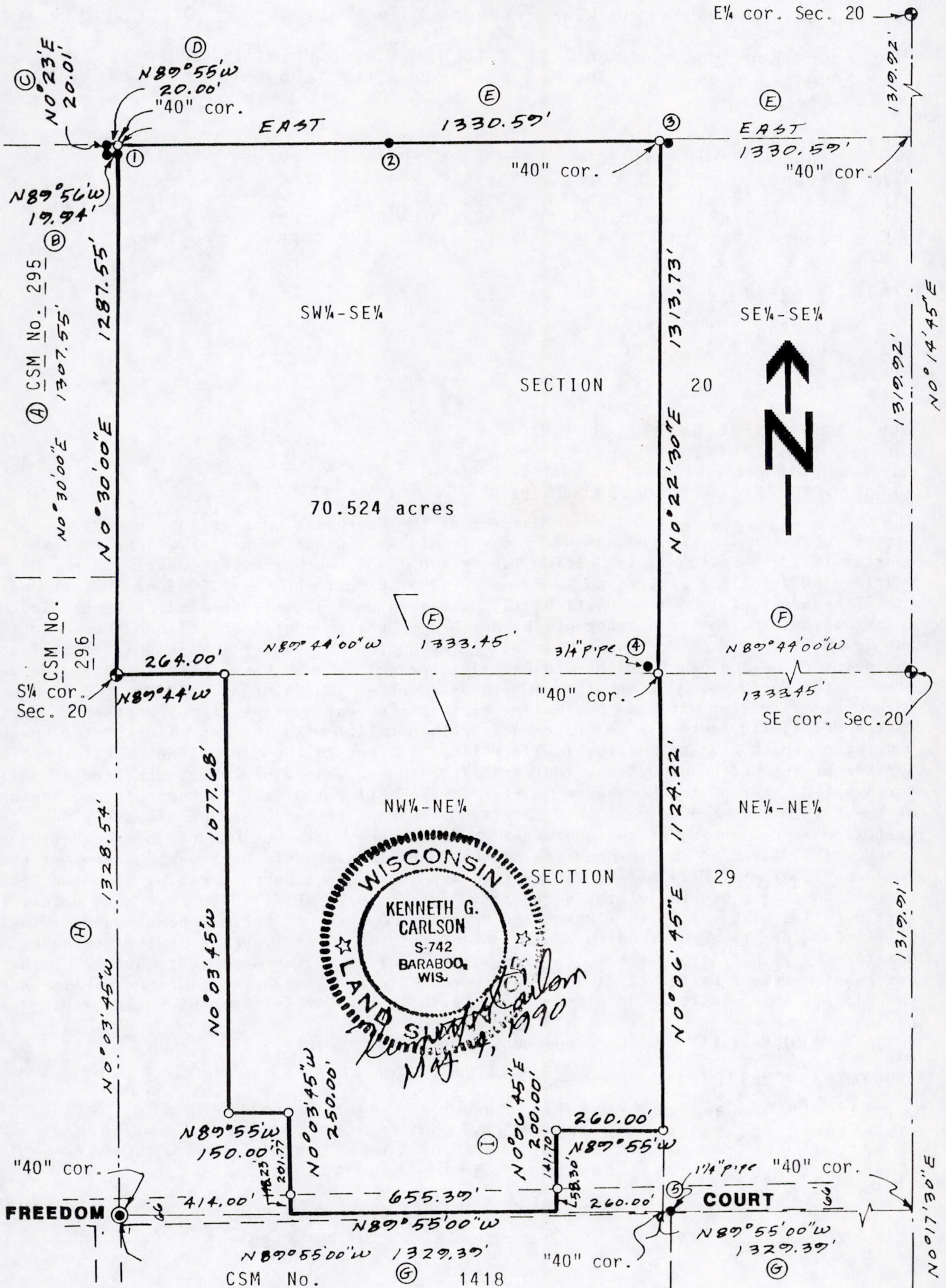


Located in Sections 20 and 29, T15N, R6E, Town of Springville, Adams County, Wisconsin.

LEGAL DESCRIPTION (from Vol 86 page 36, mortgage):

The Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$): and a parcel 20 feet square in the northeast corner of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$), all in Section Twenty (20); and the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Twenty-nine (29), EXCEPT the West 264 feet thereof and EXCEPT a parcel of land more particularly described as follows: Commencing at the Southwest corner of said Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) and thence East on the South line of said Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 264 feet to the point of beginning of the herein described parcel; thence North parallel with the West line of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 250 feet to a point; thence East parallel with the South line of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 150 feet to a point; thence South parallel with the West line of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 250 feet to the South line of said Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$); thence West along the South line of said Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 150 feet to the point of beginning of the herein excepted parcel; ALSO EXCEPTING a parcel of land more particularly described as follows: Commencing at the Southeast corner of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) and thence West on the South line of said Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 260 feet to a point; thence North parallel with the West line of said Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 200 feet to a point; thence East parallel with the South line of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 260 feet to a point on the East line of said Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$); thence South along the East line of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) 200 feet to the point of commencement of the herein excepted parcel; ALL being in Township Fifteen (15) North, Range Six (6) East of the Fourth Principal Meridian.

Subject to highway right of ways and public utility easements.
