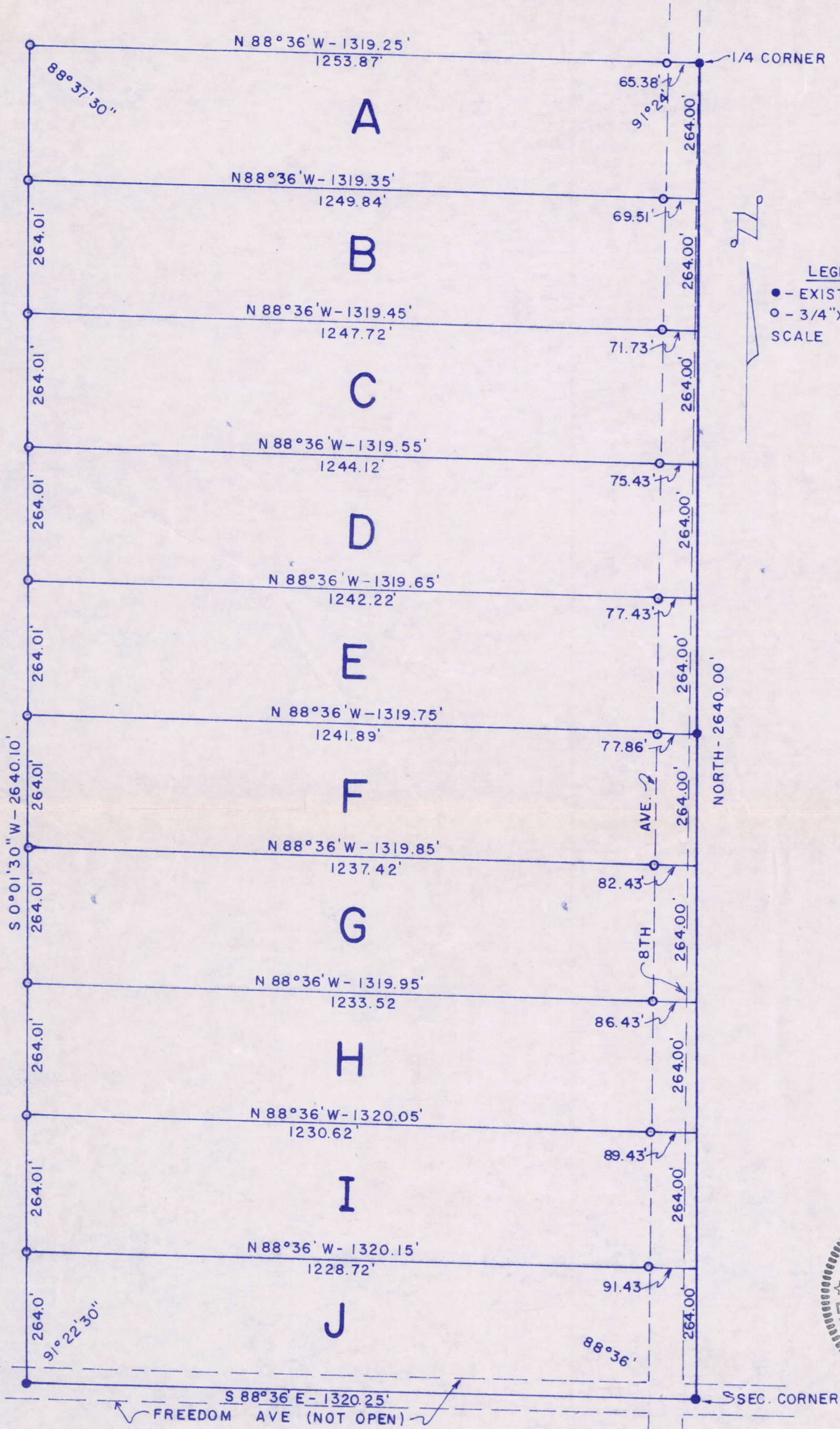


WHITEMARSH REALTY

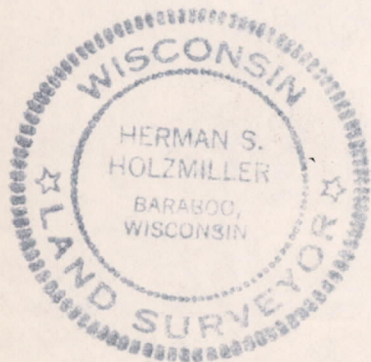

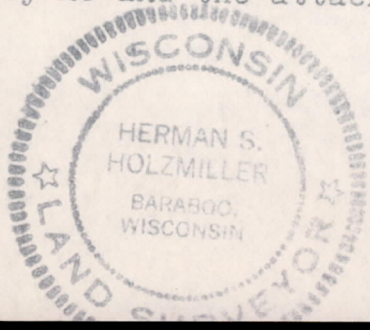
