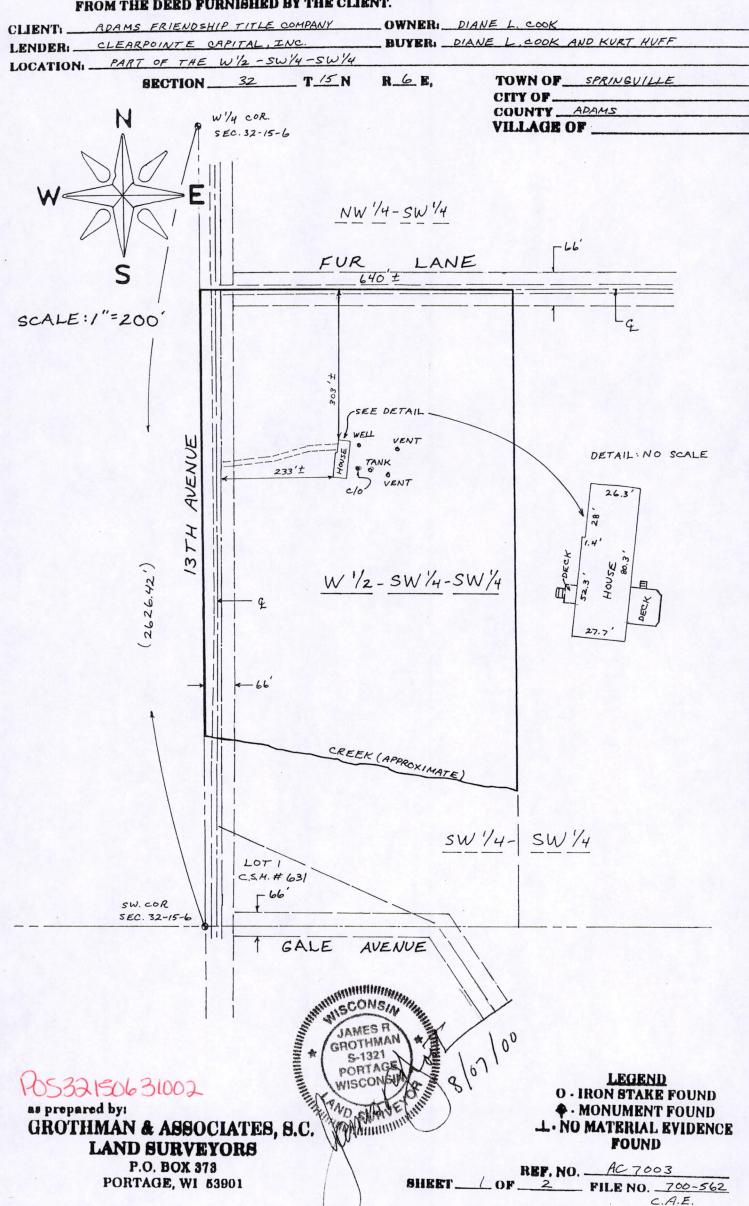
## **MORTGAGE INSPECTION**
