

SURVEYOR'S CERTIFICATE

I, Fred W. Zietlow, Registered Land Surveyor, hereby certify that I have surveyed and mapped a parcel of land located in the NE¼-NW¼, NW¼-NE¼, SW¼-NE¼ and SE½-NE¼ Section 3, T15N, R7E, Town of Jackson, Adams County, Wisconsin, which is bounded by a line described as follows:
