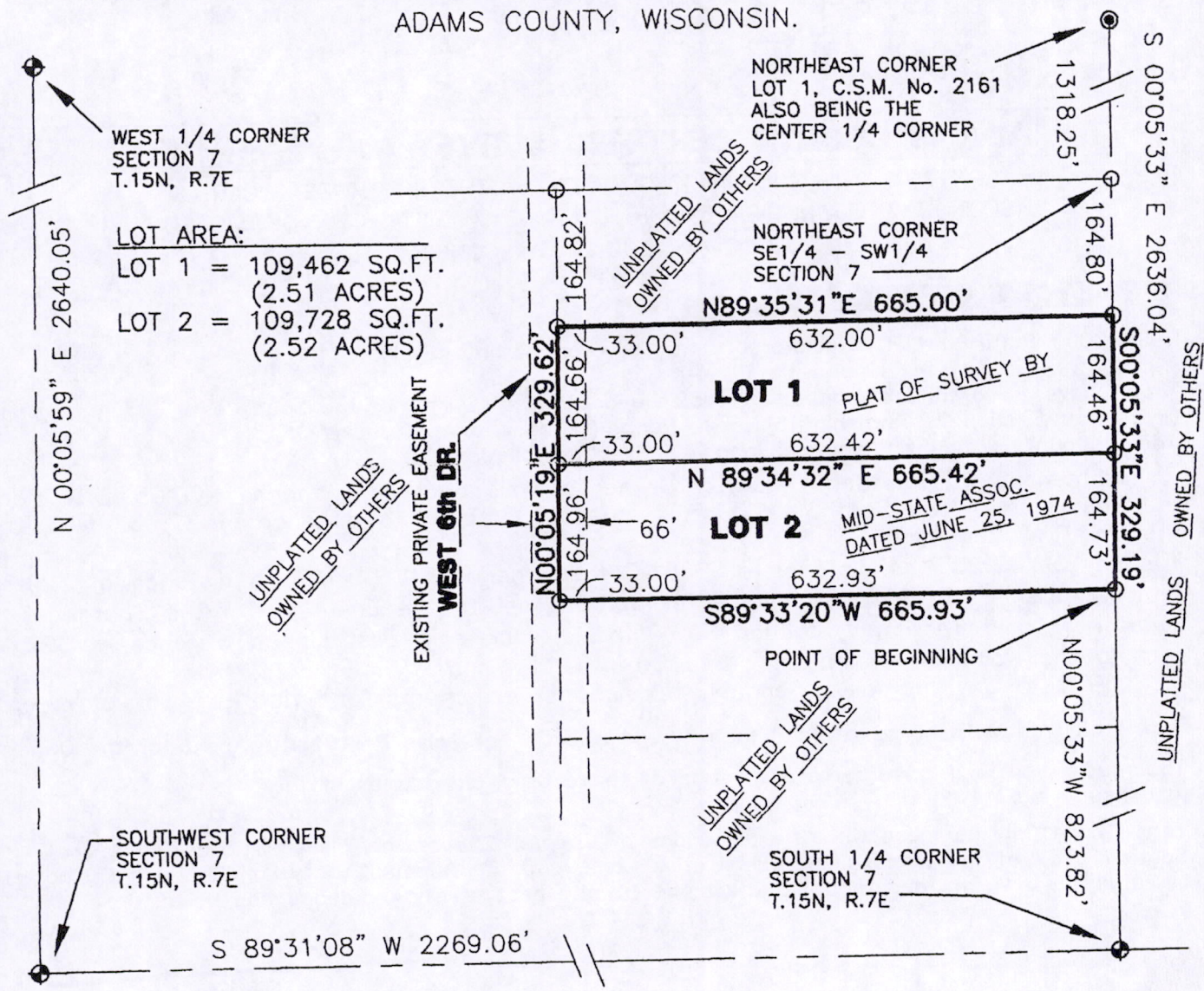

That I have surveyed and mapped part of the Southeast Quarter of the Southwest Quarter of Section 7, Township 15 North, Range 7 East, Town of Jackson, Adams County, Wisconsin, bounded and described as follows;

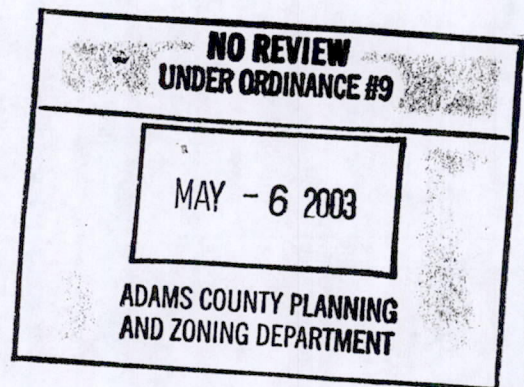
Commencing at the South Quarter Corner of said Section 7, thence N00°05'33"W along the East Line of the Southwest Quarter of said Section 7 a distance of 823.82 feet to the Point of Beginning.
Thence S89°33'20"W a distance of 665.93 feet; thence N00°05'19"E a distance of 329.62 feet; thence N89°35'31"E a distance of 665.00 feet to the East Line of the Southwest Quarter of said Section 7; thence S00°05'33"E along said East Line a distance of 329.19 feet to the Point of Beginning. Containing 219,190 sq.ft. (5.03 Acres).
