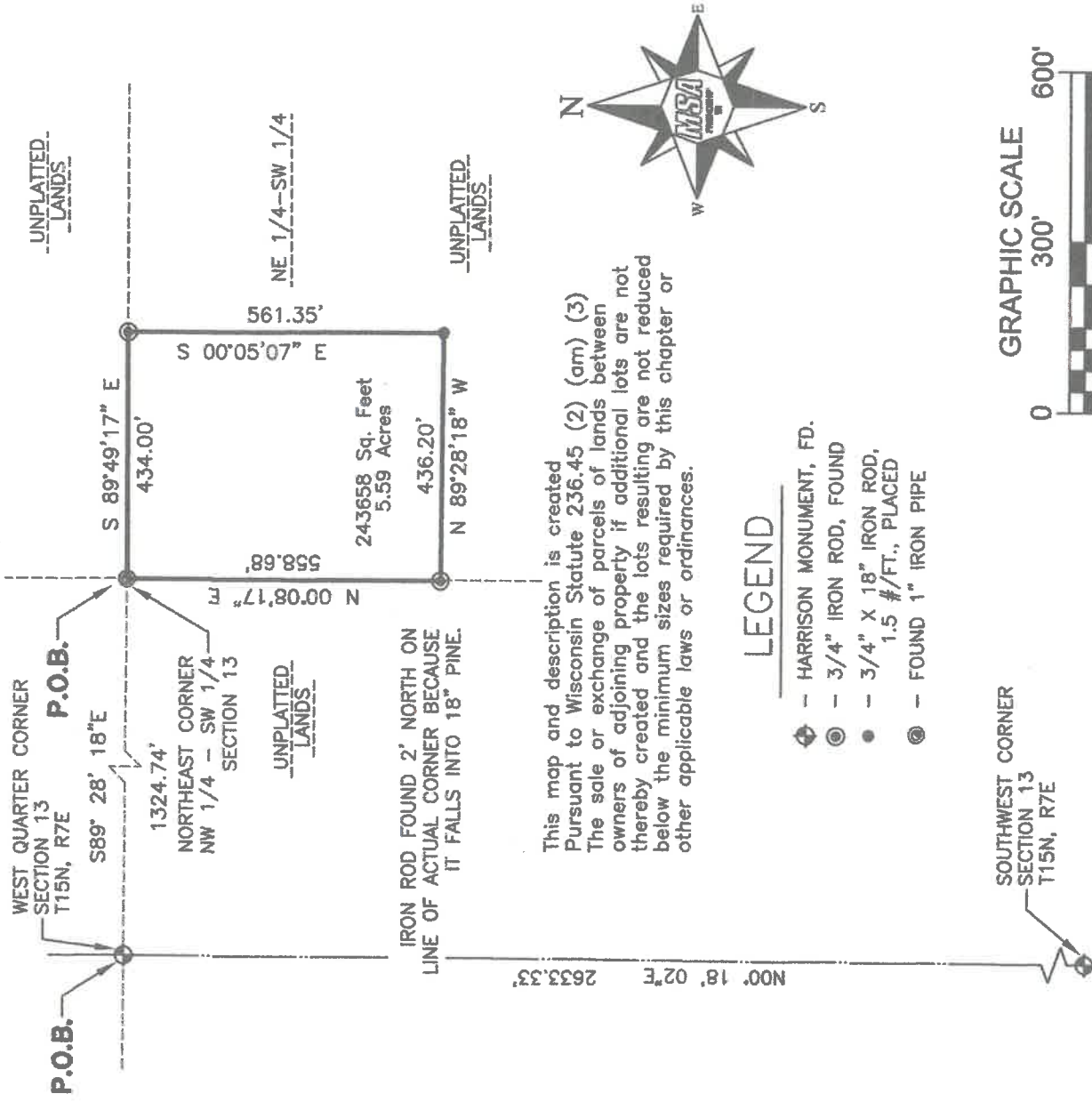

thence S00°05'07"E a distance of 561.35 feet;

thence N89°28'18"W a distance of 436.20 feet;

thence N00°08'17"E a distance of 558.68 feet to the the POINT OF BEGINNING.;
