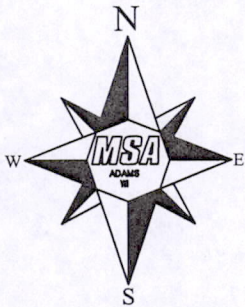

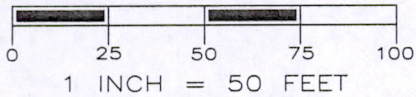

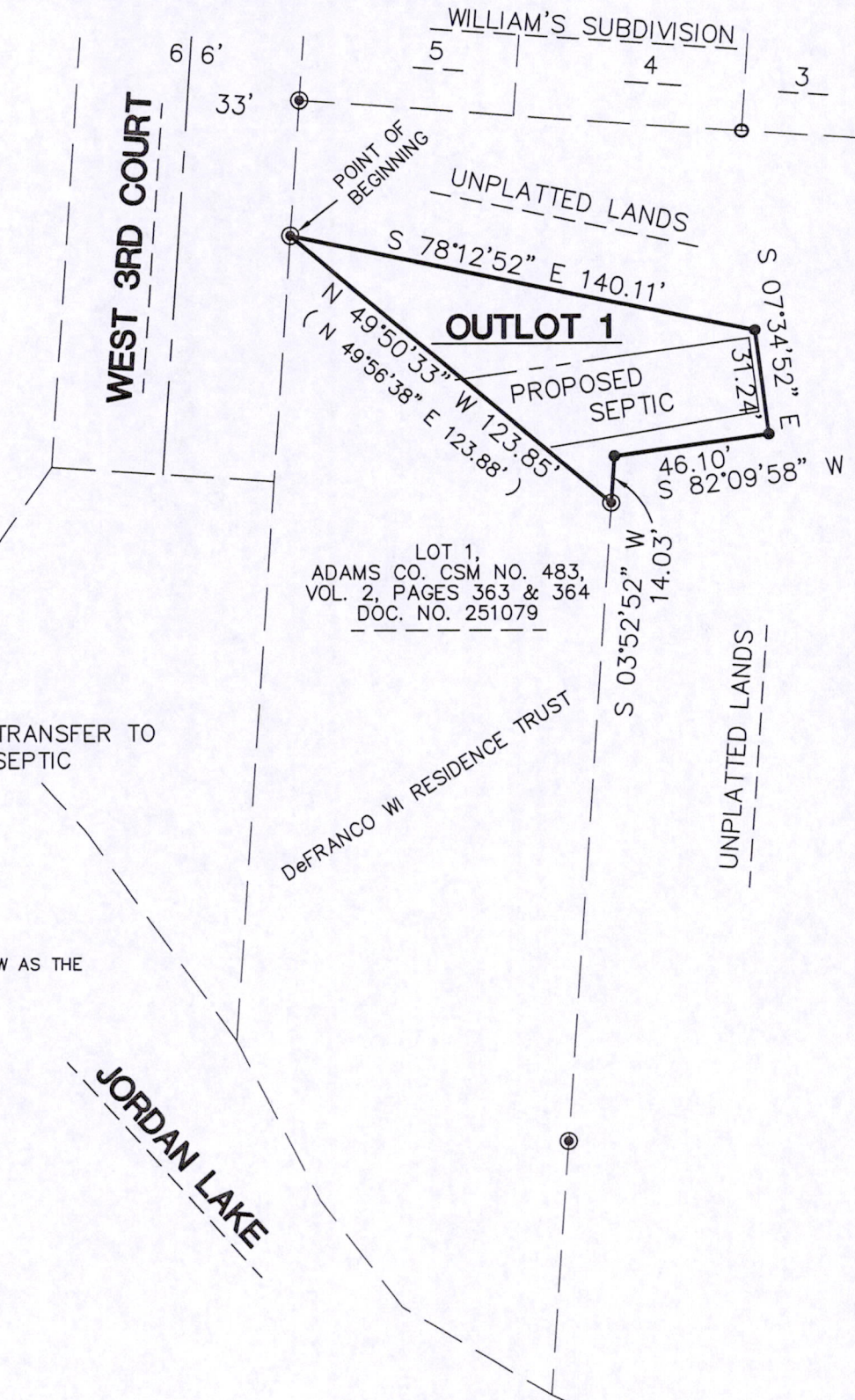


Beginning at the northwest corner of Lot 1, Adams County Certified Survey Map No. 483, as recorded in Volume 2 of Surveys on pages 363 and 364 with Document No. 251079, thence S78°12'52"E a distance of 140.11 feet, thence S07°34'52"E a distance of 31.24 feet, thence S82°09'58"W a distance of 46.10 feet, thence S03°52'52"W a distance of 14.03 feet to the northeast corner of said Lot 1, thence N49°50'33"E along the north line of said Lot 1 a distance of 123.85 feet to the Point of Beginning, containing 4,570 Square Feet (0.10 acres);

That I have made such survey and map at the direction of Robert Fusch, Arrowhead, Inc.;

That such map is a correct representation of the exterior boundaries of the lands surveyed;
