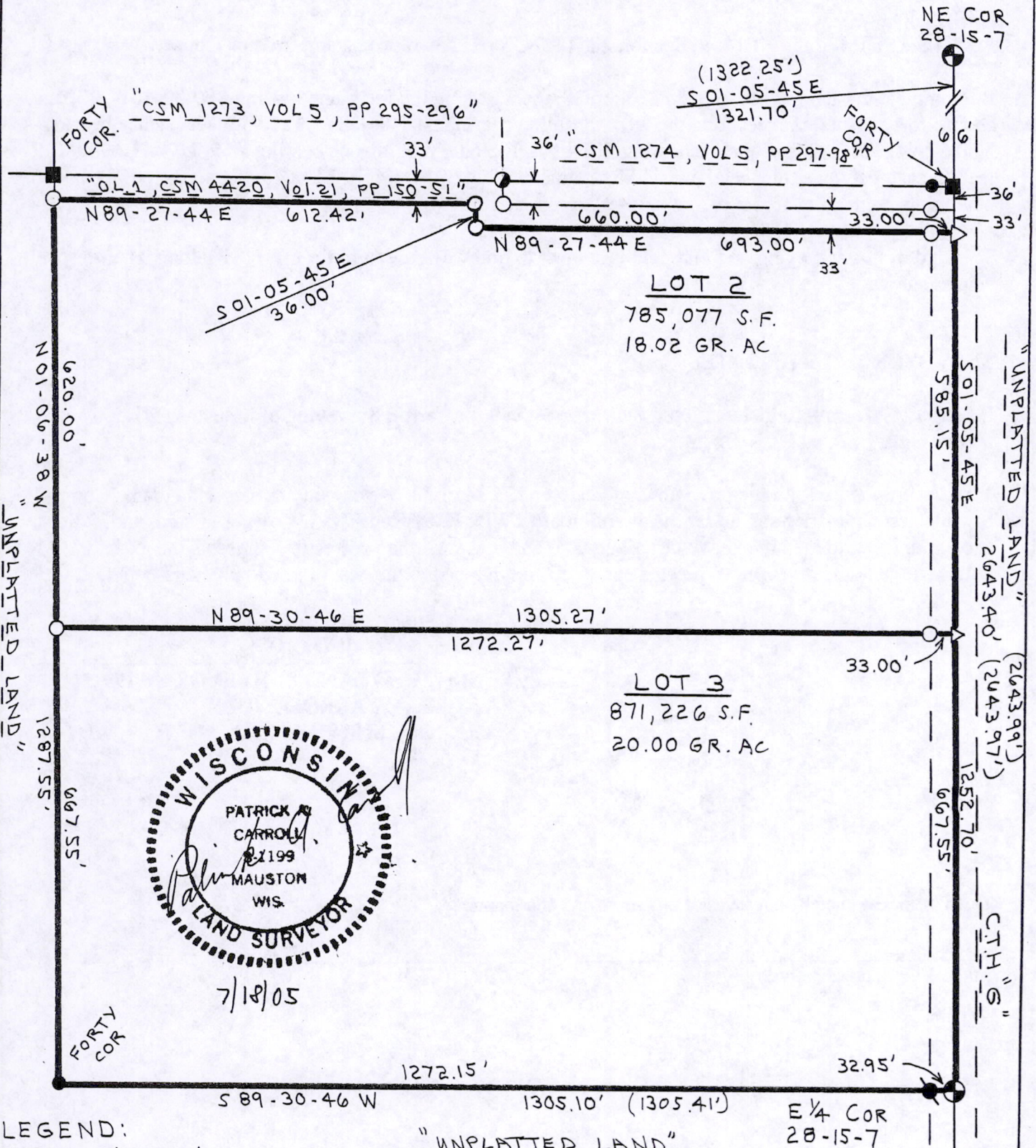

DESCRIPTION:

Part of the SE1/4 of the NE1/4 in Section 28, T15N, R7E, Town of Jackson, Adams County, Wisconsin.

Beginning at the E1/4 corner of said Section 28; thence along the forty line bearing S89-30-46W, 1305.10 feet, to forty corner; thence along the west forty line bearing N01-06-38W, 1287.55 feet; thence bearing N89-27-44E, 612.42 feet; thence bearing S01-05-45E, 36.00 feet; thence bearing N89-27-44E, 693.00 feet, to east forty line; thence along said forty line bearing S01-05-45E, 1252.70 feet, to the point of beginning, containing 1,656,303 s.f. or 38.02 gross acres.

The land of this surveying and mapping is subject to highway easement for CTH "G" along its easterly side as shown.
