

DESCRIPTION OF OUTLOT 1:

Part of Lot 1 of Adams County Certified Survey Map #1013, Vol. 4, pages 384-385, located in part of the NW1/4 of the SE1/4 in Section 35, T15N, R7E, Town of Jackson, Adams County, Wisconsin.

Commencing at the S1/4 corner of said Section 35; thence bearing N29-04-10E, 2038.37 feet, to the point of beginning. Thence bearing N00-28-11W, 59.90 feet; thence bearing S80-53-14E, 356.73 feet, to the centerline of 2nd Court; thence bearing S89-26-46W, 351.75 feet, to the point of beginning, containing 10,535 s.f. or 0.24 gross acres.

Outlot 1 of this surveying and mapping is subject to highway easement for 2nd Court being the easterly 33 feet thereof.

DESCRIPTION OF OUTLOT 2:

Part of Lot 1 of Adams County Certified Survey Map #1013, Vol. 4, pages 384-385, located in part of the NW1/4 of the SE1/4 in Section 35, T15N, R7E, Town of Jackson, Adams County, Wisconsin.

Commencing at the S1/4 corner of said Section 35; thence bearing N29-04-10E, 2038.37 feet, to the point of beginning. Thence bearing N89-26-46E, 351.75 feet, to the centerline of 2nd Court; thence along said centerline bearing S01-56-00W, 101.37 feet; thence bearing N89-34-14W, 347.54 feet; thence bearing N00-28-11W, 95.31 feet, to the point of beginning, containing 34,372 s.f. or 0.79 gross acres.

Outlot 2 of this surveying and mapping is subject to highway easement for 2nd Court being the easterly 33 feet thereof.
