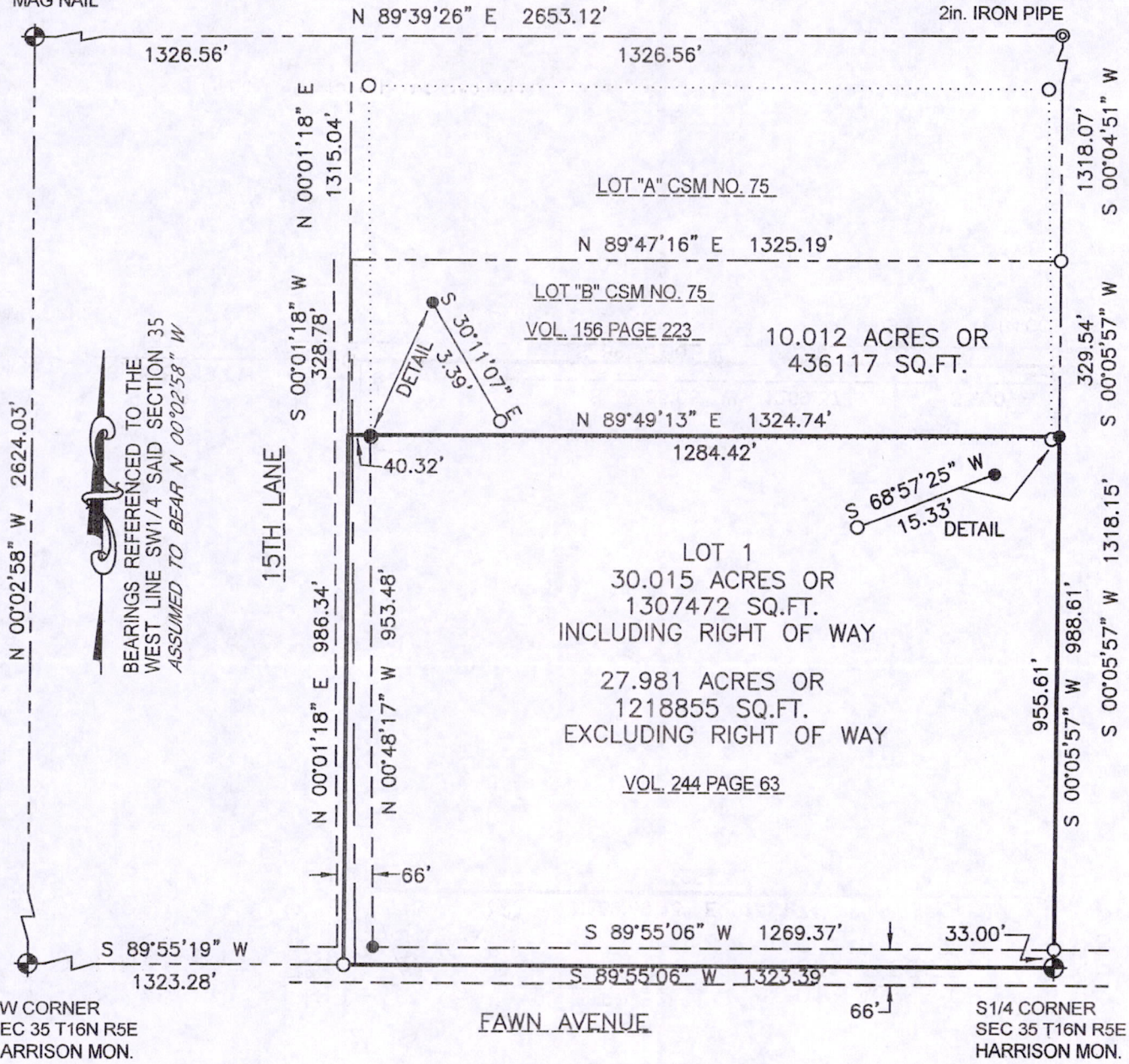


**PLAT OF SURVEY MAP

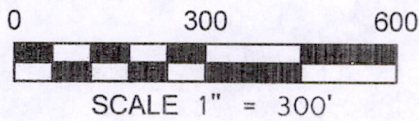

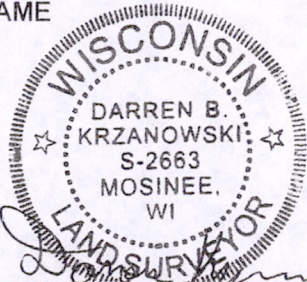
