PARCEL "A"

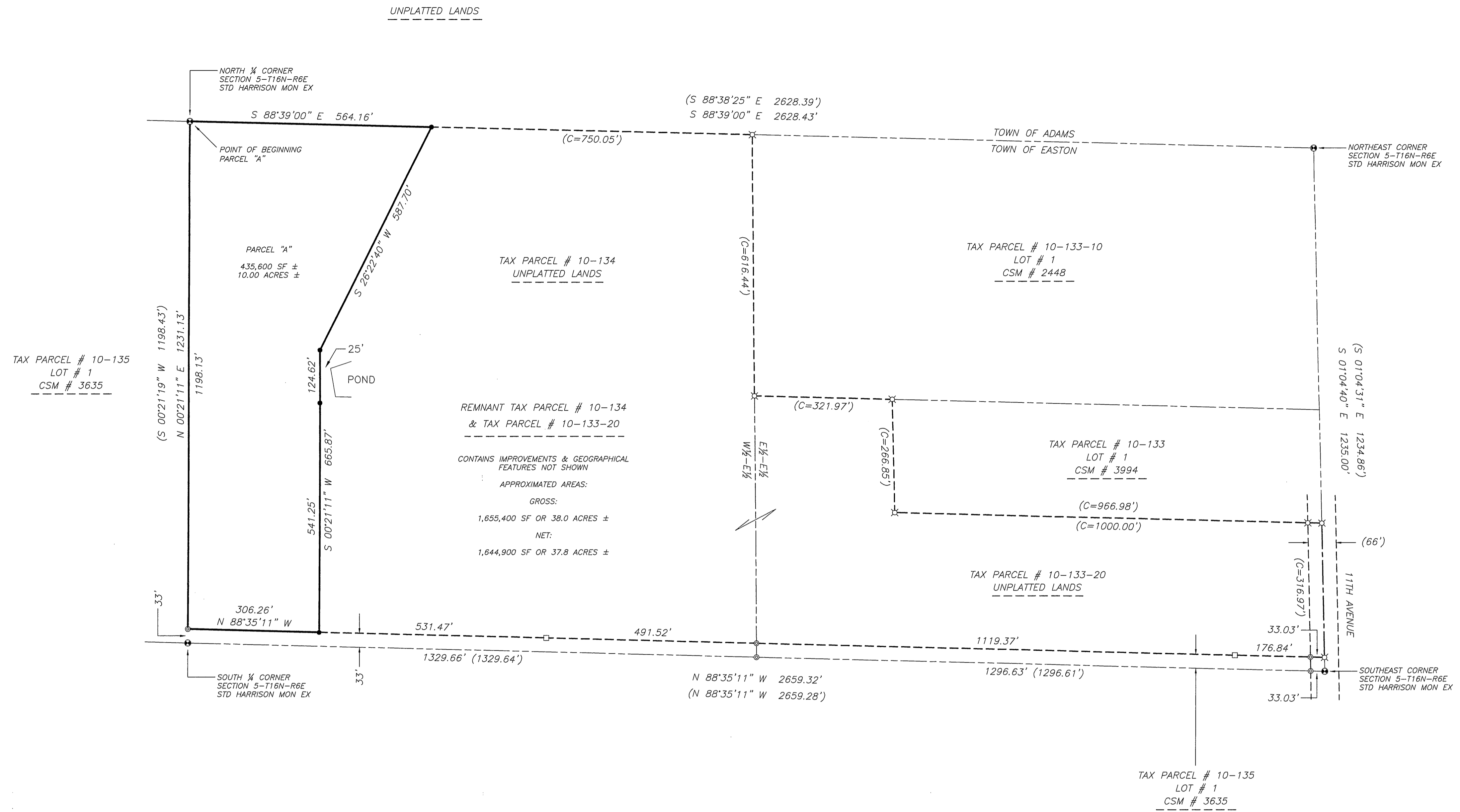
A PARCEL OF LAND LOCATED IN THE WEST ONE-HALF (W½) OF THE EAST ONE-HALF (E½) OF FRACTIONAL SECTION 5, TOWNSHIP 16 NORTH, RANGE 6 EAST, EASTON TOWNSHIP, ADAMS COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTH ONE-QUARTER CORNER OF FRACTIONAL SECTION 5;
THENCE S 88°39'00" E, A DISTANCE OF 564.16 FEET ALONG THE NORTH LINE OF FRACTIONAL SECTION 5;
THENCE S 26°22'40" W, A DISTANCE OF 587.70 FEET;
THENCE S 00°21'11" W, A DISTANCE OF 665.87 FEET TO A NORTHERLY LINE OF LOT 1 OF ADAMS COUNTY CERTIFIED SURVEY MAP 3635;
THENCE N 88°35'11" W, A DISTANCE OF 306.26 FEET ALONG SAID NORTHERLY LINE;
THENCE N 00°21'11" E, A DISTANCE OF 1198.13 FEET ALONG THE NORTH-SOUTH ONE-QUARTER (¼) LINE OF FRACTIONAL SECTION 5 AND AN EASTERLY LINE OF LOT 1 OF ADAMS COUNTY CERTIFIED SURVEY MAP 3635 TO THE POINT OF BEGINNING.

DESCRIBED PARCEL "A" CONTAINS 435,600 SQUARE FEET OR 10.000 ACRES OF LAND, MORE OR LESS.

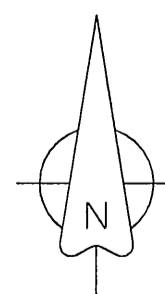

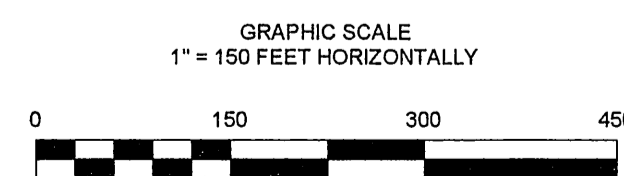
