


ADAMS COUNTY PLAT OF SURVEY

I, Robert T. Welch, Registered Land Surveyor, hereby certify:

That under the direction of First Wachovia, I have surveyed and mapped this Plat of Survey located in part of the N.E. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ and the N.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ and the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ and part of the N.W. $\frac{1}{4}$ of the S.W. $\frac{1}{4}$ of Section 25, T.16 N., R.6 E., Town of Easton, Adams County, Wisconsin described as follows:
Beginning at the N. $\frac{1}{4}$ Corner of Section 25; thence S.89°38'22"E. 2673.58'; thence SOUTH 759.52'; thence N.89°38'22"W. 264.00'; thence SOUTH 240.00'; thence S.89°38'22"E. 264.00'; thence SOUTH 313.00'; thence N.89°49'57"W. 1333.62'; thence S.00°08'13"E. 1317.04'; thence S.89°58'24"W. 1330.46' to the Center of said Section; thence S.00°16'23"E. 1315.98'; thence S.89°52'39"W. 2627.17'; thence N.00°38'54"E. 1320.45'; thence N.89°58'24"E. 278.04'; thence S.37°16'22"E. 293.17' to a Point on the Arc of a Curve to the left having Radius of 505.73' and a Central Angle of 41°41'29"; thence Southeasterly 367.99' along the Arc of said curve the Chord of which bears S.56°33'01"E. 359.93'; thence S.78°57'47"E. 72.01'; thence N.00°01'36"W. 445.73'; thence N.89°58'24"E. 1779.58' to the Center of Section 25; thence N.00°16'23"W. 2643.14' to the Point of Beginning. Subject to all Easements and Restrictions of Record.
That said map is a correct representation of the exterior boundaries of the land surveyed; that I have fully complied with the provisions of the State and County Ordinances in surveying and mapping the same to the best of my knowledge and beliefs.
