TRACT 1

A parcel of land located in the NW¼-NE¼ Section 32, T16N, R6E, Town of Easton, Adams County, Wisconsin, which is bounded by a line described as follows:
 Beginning at the north one-quarter corner of said Section 32;
 thence S87°10'57"E, 899.47 feet along the north line of said Section 32;
 thence S05°42'22"E, 189.22 feet; thence S79°46'W, 747.44 feet to a point in the centerline of Evergreen Avenue; thence N38°27'W, 300.22 feet along the centerline of Evergreen Avenue to a point on the north-south one-quarter line of said Section 32; thence N02°12'53"E, 130.27 feet along the north-south one-quarter line of said Section 32 to the point of beginning.
 Said parcel contains 5.59 acres, and is subject to easements of record.

TRACT 2

A parcel of land located in the NW¼-NE¼ Section 32, T16N, R6E, Town of Easton, Adams County, Wisconsin, which is bounded by a line described as follows:
 Commencing at the north one-quarter corner of said Section 32; thence S02°12'53"W, 130.27 feet along the north-south one-quarter line of said Section 32 to a point in the centerline of Evergreen Avenue; thence S38°27'E, 300.22 feet along the centerline of Evergreen Avenue to the point of beginning;
 thence N79°46'E, 747.44 feet; thence S16°50'39"E, 124.25 feet; thence S32°03'52"E, 74.22 feet; thence S51°33'W, 604.72 feet to a point in the centerline of Evergreen Avenue; thence N38°27'W, 542.68 feet along the centerline of Evergreen Avenue to the point of beginning.
 Said parcel contains 5.39 acres, and is subject to easements of record.

TRACT 3

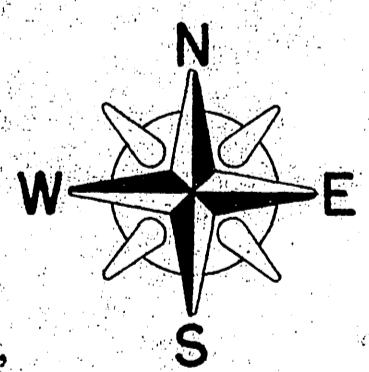
A parcel of land located in the NW¼-NE¼ Section 32, T16N, R6E, Town of Easton, Adams County, Wisconsin, which is bounded by a line described as follows:
 Commencing at the north one-quarter corner of said Section 32; thence S02°12'53"W, 130.27 feet along the north-south one-quarter line of said Section 32 to a point in the centerline of Evergreen Avenue; thence S38°27'E, 842.90 feet along the centerline of Evergreen Avenue to the point of beginning;
 thence N51°33'E, 604.72 feet; thence S41°47'53"E, 210.81 feet; thence S64°24'14"E, 181.18 feet to a point on the east line of the NW¼-NE¼ of said Section 32; thence S52°42'12"W, 696.48 feet to a point in the centerline of Evergreen Avenue; thence N38°27'W, 359.34 feet along the centerline of Evergreen Avenue to the point of beginning.
 Said parcel contains 5.30 acres and is subject to an easement of 2 rods over the easterly corner thereof for ingress and egress to Tract #5.

TRACT 4

A parcel of land located in the NW¼-NE¼ Section 32, T16N, R6E, Town of Easton, Adams County, Wisconsin, which is bounded by a line described as follows:
 Commencing at the north one-quarter corner of said Section 32; thence S02°12'53"W, 130.27 feet along the north-south one-quarter line of said Section 32 to a point in the centerline of Evergreen Avenue; thence S38°27'E, 122.24 feet along the centerline of Evergreen Avenue to the point of beginning;
 thence N52°42'12"E, 696.48 feet to a point on the east line of the NW¼-NE¼ of said Section 32; thence S02°09'38"W, 744.46 feet along the east line of the NW¼-NE¼ of said Section 32 to a point in the centerline of Evergreen Avenue; thence N88°19'W, 126.95 feet along the centerline of Evergreen Avenue to a point of curve; thence along the arc of a curve concave to the northeast, radius 322.66 feet, whose chord bears N63°23'W, 272.04 feet; thence N38°27'W, 250.66 feet along the centerline of Evergreen Avenue to the point of beginning.
 Said parcel contains 5.50 acres, and is subject to an easement over the easterly 2 rods for ingress and egress to Tract 5.

TRACT 5

A parcel of land located in the NW¼-NE¼ Section 32, T16N, R6E, Town of Easton, Adams County, Wisconsin, which is bounded by a line described as follows:

 thence continuing S87°10'57"E, 420.80 feet along the north line of said Section 32 to the northeast corner of the NW¼-NE¼ of said Section 32; thence S02°09'38"W, 585.20 feet along the east line of the NW¼-NE¼ of said Section 32; thence N64°24'18"W, 181.18 feet; thence N41°47'53"W, 210.81 feet; thence N32°08'52"W, 74.22 feet; thence N16°50'39"W, 124.25 feet; thence N05°42'22"W, 189.22 feet to the point of beginning.
 Said parcel contains 4.18 acres, and is subject to easements of record.
