



DESCRIPTION PARCEL "A"

A parcel of land located in Adams County Wisconsin, in the NW $\frac{1}{4}$ -NW $\frac{1}{4}$ of section 13, T 16 N, R 7 E which is bounded by a line described as follows:

Beginning at the northwest corner of said section 13; thence S 89°58' E, 466.00 feet along the center of C.T.H. "E"; thence South 666.14 feet; thence N 89°58' W, 470.00 feet; thence N 0°21' E, 666.14 feet along the center of 2nd Ave to the point of beginning. Said parcel contains 7.16 acres and is subject to the right-of-way of the above mentioned roads.
