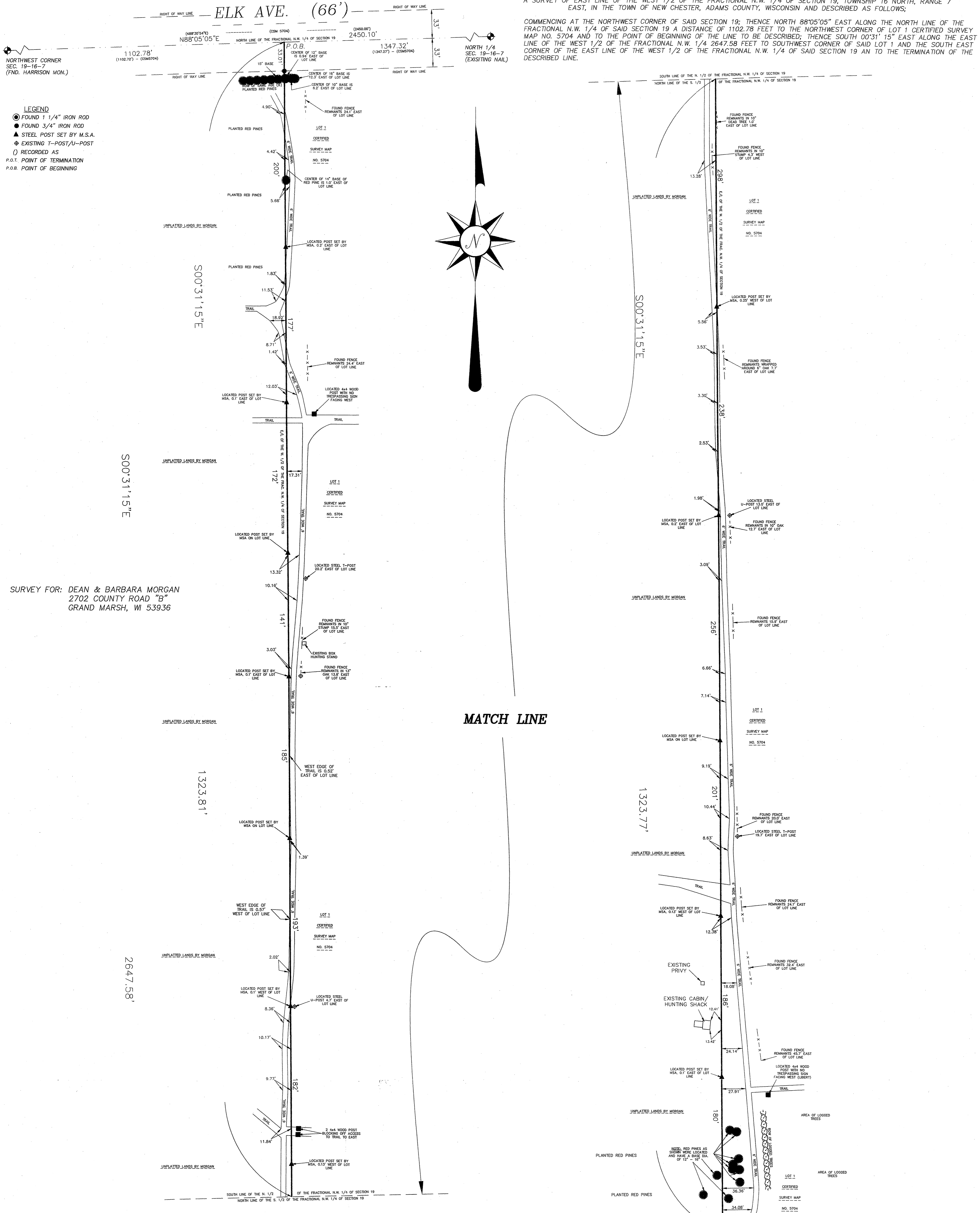


# LINE SURVEY

A SURVEY OF EAST LINE OF THE WEST 1/2 OF THE FRACTIONAL N.W. 1/4 OF SECTION 19, TOWNSHIP 16 NORTH, RANGE 7 EAST, IN THE TOWN OF NEW CHESTER, ADAMS COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS;

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 19; THENCE NORTH 88°05'05" EAST ALONG THE NORTH LINE OF THE FRACTIONAL N.W. 1/4 OF SAID SECTION 19 A DISTANCE OF 1102.78 FEET TO THE NORTHWEST CORNER OF LOT 1 CERTIFIED SURVEY MAP NO. 5704 AND TO THE POINT OF BEGINNING OF THE LINE TO BE DESCRIBED; THENCE SOUTH 00°31'15" EAST ALONG THE EAST LINE OF THE WEST 1/2 OF THE FRACTIONAL N.W. 1/4 2647.58 FEET TO SOUTHWEST CORNER OF SAID LOT 1 AND THE SOUTH EAST CORNER OF THE EAST LINE OF THE WEST 1/2 OF THE FRACTIONAL N.W. 1/4 OF SAID SECTION 19 AN TO THE TERMINATION OF THE DESCRIBED LINE.

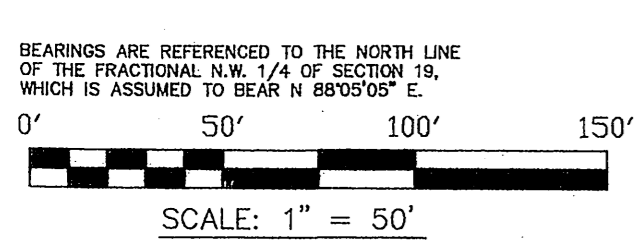
