

That in compliance with the provisions of Chapter 236.34 of the Wisconsin Statutes and under the direction of VIRGIL SEYMOUR, owner of said land, I did survey, divide and map Parcel 4 of C.S.M. #1702 recorded in Volume 6 at Page 429 being a part of the NE_4^1 of the NW_4^1 in Section 22, T16N, R7E, in the Town of New
