PARCEL "A"

A parcel of land located in Adams County Wisconsin, in the SE $\frac{1}{4}$ -SW $\frac{1}{4}$ and the east $\frac{1}{2}$ of the SW $\frac{1}{4}$ -SW $\frac{1}{4}$ of Section 26, T 16 N, R 7 E which is bounded by a line described as follows:

Beginning at the south one quarter corner of said section 26; thence north 441.00 feet along the one quarter line; thence S 89°04' W, 1980 feet to the west line of the east one half of said SW $\frac{1}{4}$ -SW $\frac{1}{4}$; thence south 443.00 feet along said west line to the south line of said section 26; thence N 89°00' E, 1980 feet to the point of beginning. Said parcel contains 20.00 acres and is subject to the right-of-way of 2nd avenue.

PARCEL "B"

A parcel of land located in Adams County Wisconsin, in the SE $\frac{1}{4}$ -SW $\frac{1}{4}$ and the east $\frac{1}{2}$ of the SW $\frac{1}{4}$ -SW $\frac{1}{4}$ of Section 26, T 16 N, R 7 E which is bounded by a line described as follows:

Beginning at a point on the one quarter line of said section 26 which is 441.00 feet north from the south one quarter corner thereof; thence continuing north 441.00 feet along said one quarter line; thence S 89°08' W, 1980 feet to the west line of the east one half of said SW $\frac{1}{4}$ -SW $\frac{1}{4}$; thence 443.00 feet; thence N 89°04' E, 1980 feet to south along said west line to the point of beginning. Said parcel contains 20.00 acres and is subject to the right-of-way of 2nd avenue.

PARCEL "C"

A parcel of land located in Adams County Wisconsin, in the SE $\frac{1}{4}$ -SW $\frac{1}{4}$ and the east $\frac{1}{2}$ of the SW $\frac{1}{4}$ -SW $\frac{1}{4}$ of Section 26, T 16 N, R 7 E which is bounded by a line described as follows:

Beginning at a point on the one quarter line of said section 26 which is 882 feet north from the south one quarter corner thereof; thence north 441 feet to the northeast corner of said SE $\frac{1}{4}$ -SW $\frac{1}{4}$; thence S 89°12' W, 1980 feet to the mid point of the north line of said SW $\frac{1}{4}$ -SW $\frac{1}{4}$; thence south 443 feet along the west line of the east one half of the SW $\frac{1}{4}$ -SW $\frac{1}{4}$; thence N 89°08' E, 1980 feet to the point of beginning. Said parcel contains 20.00 acres and is subject to the right-of-way of 2nd avenue.
