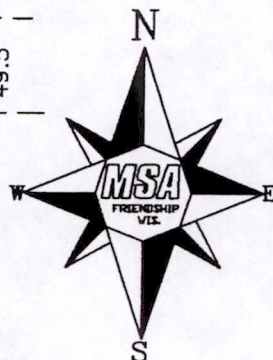
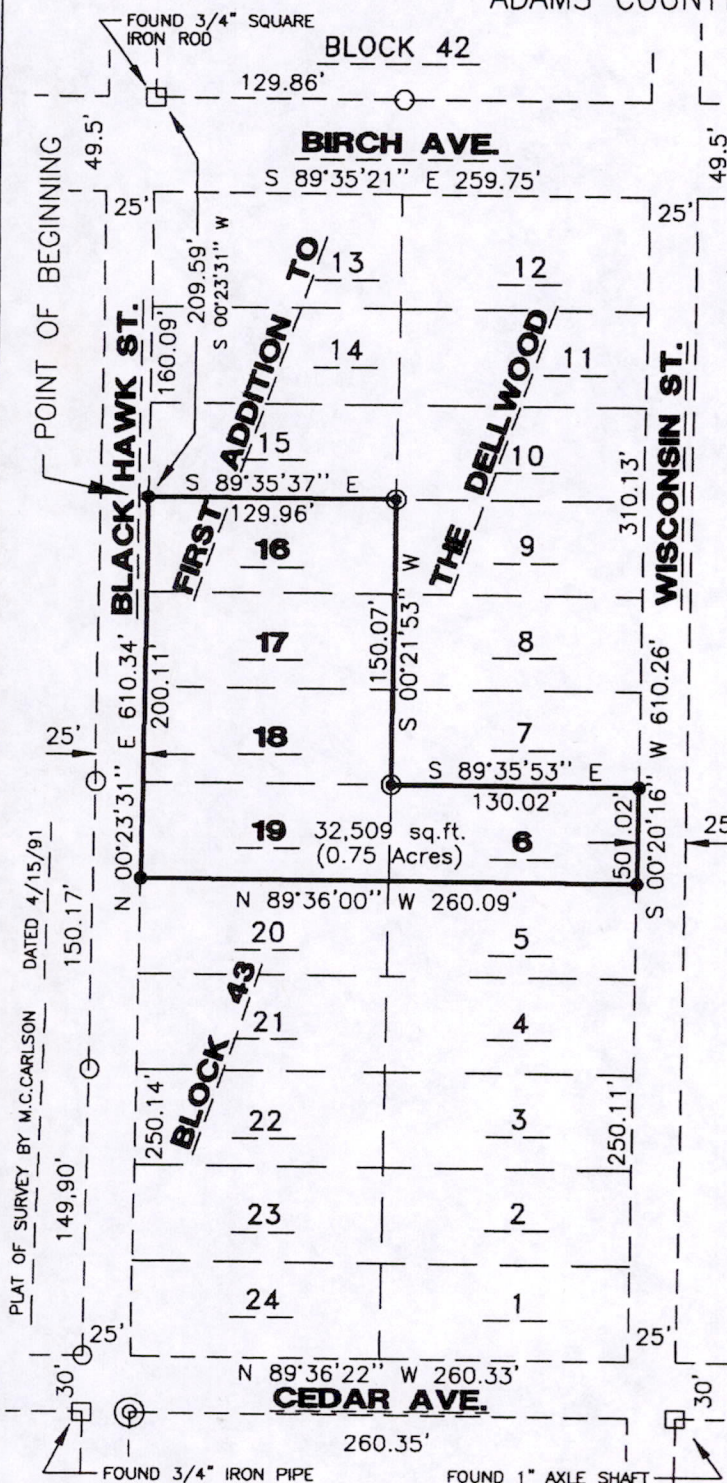

ADAMS COUNTY, WISCONSIN.

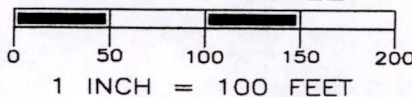

Commencing at the Southwest Corner of Block 42, First Addition to the Dellwoods, thence S00°23'31"W 209.59 feet to the Northwest Corner of Lot 16, Block 43, First Addition to the Dellwood and the Point of Beginning.

Thence S89°35'37"E 129.96 feet to the Northeast Corner of said Lot 16; thence S00°21'53"W 150.07 feet to the Northwest Corner of Lot 6, Block 43, First Addition to the Dellwood; thence S89°35'53"E 130.02 feet to the Northeast Corner of said Lot 6; thence S00°20'16"W 50.02 feet to the Southeast Corner of said Lot 6; thence N89°36'00"W 260.09 feet to the Southwest Corner of Lot 19, Block 43, First Addition to the Dellwood; thence N00°23'31"E 200.11 feet to the Northwest Corner of Lot 16, Block 43, First Addition to the Dellwood and the Point of Beginning.
