PLAT OF SURVEY

Lots 14, 15, 16, 17 and 18 of Block 88 of Second Addition to the Dellwood as recorded in File 1 of Plats at Envelope 34. Located in Government Lot 1 of Section 18, Township 17 North, Range 5 East, Town of Quincy, Adams County, Wisconsin.

DESCRIPTION:

Lots 14, 15, 16, 17 and 18 of Block 88 of the Second Addition to the Dellwood, located in Government Lot 1 of Section 18, Township 17 North, Range 5 East, Town of Quincy, Adams County, Wisconsin, described as follows; Commencing at the Southeast corner of Lot 1 of said Block 88, thence N 89°30'52" W along the South line of Lot 1 of said Block 88 and an extension thereof a distance of 137.38 feet to the centerline of Vacated Church Street and the POINT OF BEGINNING, thence continuing N 89°30'52" W along the South line of Lot 18 of said Block 88 and an extension thereof a distance of 48.00 feet to a meander line of Castle Rock Flowage, thence N 03°22'53" W along said meander line a distance of 250.57 feet to the North line of Lot 14 of said Block 88, thence S 89°29'12" E along said North line and an extension thereof a distance of 62.42 feet to the centerline of said Vacated Church Street, thence S 00°04'57" E along said centerline a distance of 249.98 feet to the POINT OF BEGINNING. Including all lands lying between the lot lines extended, the meander line and the water's edge of Castle Rock Flowage.


