

DESCRIPTION

Parcel I: All that part of the Southwest Quarter of Section 33, Township 17 North, Range 5 East described as follows: Commencing at the west quarter corner of said Section 33; thence South 89°54' East, 1,116.80 feet to the point of beginning; thence due south 440 feet to a point; thence South 89°54' East, 36.66 feet to a point; thence North 47°30' East, 117.38 feet to a point; thence due North 360.55 feet to a point; thence North 89°54' West, 123.20 feet to a point of beginning: Commonly known as Lot T - 32 of Pineorama, an unrecorded plat.

Parcel II: A part of the Southwest Quarter of Section 33, Township 17
North, Range 5 East described as follows: Commencing at the west quarter corner of said Section 33; thence South 89°54' East, 966.80 feet to the point of beginning; thence due south 440 feet; thence South 89°54' East, 150.00 feet to a point; thence due north 440.00 feet to a point; thence North 89°54' West, 150.00 feet to a point of beginning: Commonly known as Lot T - 33 of Pineorama, an unrecorded plat.

AND

A part of the Southwest Quarter of Section 33, Township 17 North, Range 5 East described as follows: Commencing at the southwest corner of said Section 33; thence north on section line, 1,260.00 feet; thence east 660.00 feet; thence north 857.34 feet; thence South 89°54' East, 7.42; thence North 00°02' West, 80 feet; thence South 89°54' East, 116.04 feet to a point of beginning: thence South 42°30' Fast 493 61 feet; thence North point of beginning; thence South 42°30' East, 493.61 feet; thence North 47°30' East, 150 feet; thence North 42°30' West, 355.55 feet; thence North 89°54' West, 203.78 feet to a point of beginning: Commonly known as Lot T - 55 of Pineorama, an unrecorded plat.
