Parcel A:

Being a part of the Northeast Quarter of the Southeast Quarter of Section 35 and all of Lot 1, Certified Survey Map No. 5471 as recorded in Volume 27 of Certified Survey Maps, page 325, as Document No. 492702 located in part of the Northwest Quarter of the Southwest Quarter and the Northeast Quarter of the Southwest Quarter of Section 36, Town 17 North, Range 5, East Town of Adams, Adams County, Wisconsin:

Beginning at the west quarter corner of said Section 35, said point also being the northwest corner of Lot 1, Certified Survey Map No. 5471;

thence North 89°41'38" East along the north line of the Southwest Quarter of said Section 36 and the north line of said Lot 1, 2,628.74 feet to the center of said Section 36;

thence North 89°41'51" East along the north line of the Southeast Quarter of said Section 36 and the north line of said Lot 1, 50.00 feet;

thence South 44°44'48" West along the east line of said Lot 1, 70.77 feet to a point in the east line of the Northwest Quarter of said Section 36;

thence South 00°12'15" East along the east line of the Southwest Quarter of said Section 36 and the east line of said Lot 1, 612.05 feet to the southeast corner of said Lot 1;

thence South 00°12'15" East along the east line of the Southwest Quarter of said Section 36, 662.05 feet to the southeast corner of the Northeast Quarter of the Southwest Quarter of said Section 36;

thence South 89°28'21" West along the south line of the Northeast Quarter of the Southwest Quarter of said Section 36, 2,628.59 feet to the southwest corner of the Northwest Quarter of the Southwest Quarter of said Section 36:

thence North 00°12'43" West along the west line of the Southwest Quarter of Section 35, 667.13 feet to the point of beginning.
