
PLAT OF SURVEY



"13"; thence along the west right-of-way line of line of S.T.H. "13" bearing S 00-38-48 E, 166.00 feet, to a point on the south line of Lot 3 of Sharmania Subdivision: thence along the south line of Lot 3 of Sherman's Subdivision; thence along the south line of said Lot 3 bearing S 89-57-41 W, 286.48 feet, to the SW corner of said Lot 3; thence along the east line of said Lot 6 bearing SOUTH, 231.00 feet, to the point of beginning.
