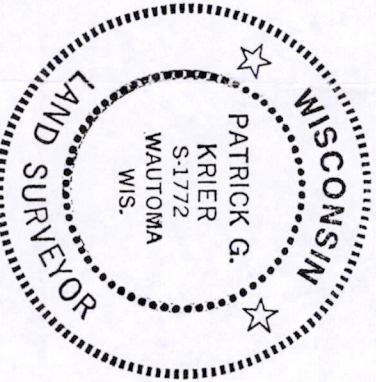


# LINE SURVEY

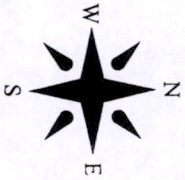

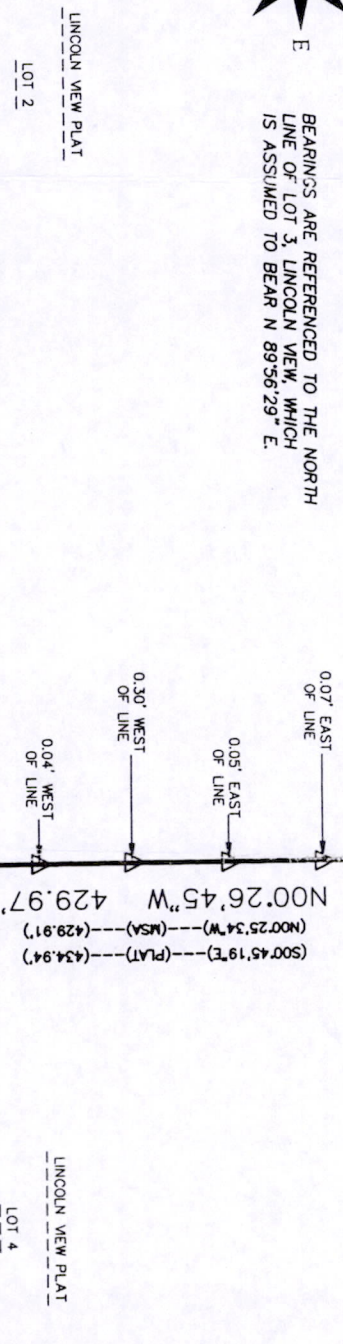
