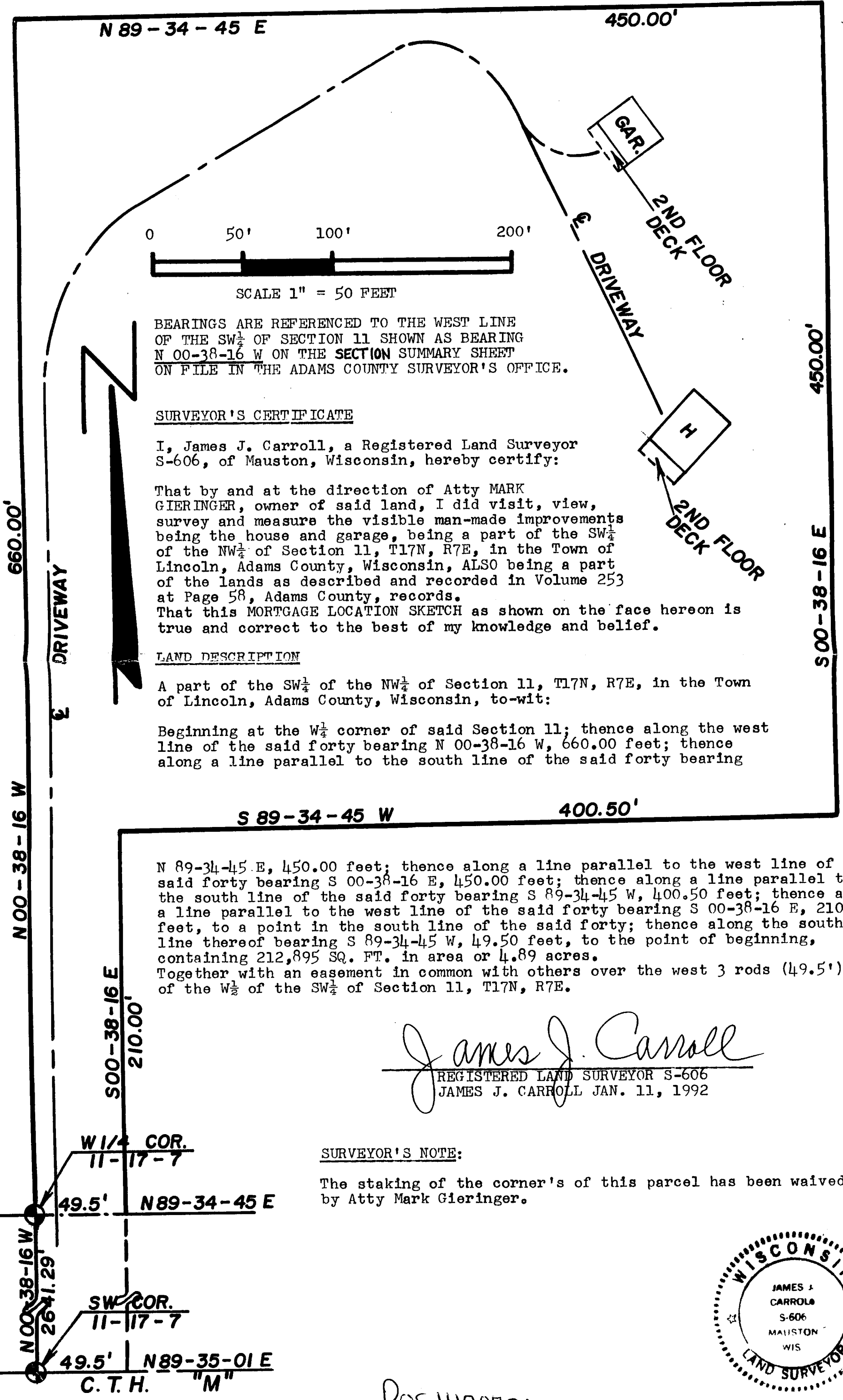


MORTGAGE LOCATION SKETCH

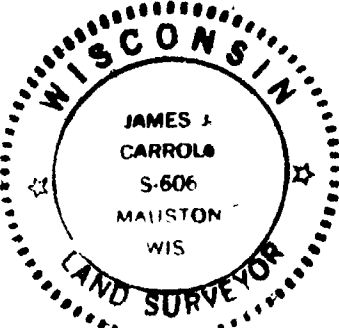
Beginning at the W $\frac{1}{4}$ corner of said Section 11; thence along the west line of the said forty bearing N 00-38-16 W, 660.00 feet; thence along a line parallel to the south line of the said forty bearing

N 89-34-45 E, 450.00 feet; thence along a line parallel to the west line of the said forty bearing S 00-38-16 E, 450.00 feet; thence along a line parallel to the south line of the said forty bearing S 89-34-45 W, 400.50 feet; thence along a line parallel to the west line of the said forty bearing S 00-38-16 E, 210.00 feet, to a point in the south line of the said forty; thence along the south line thereof bearing S 89-34-45 W, 49.50 feet, to the point of beginning, containing 212,895 SQ. FT. in area or 4.89 acres. Together with an easement in common with others over the west 3 rods (49.5') of the W $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 11, T17N, R7E.
