


COUNTY CERTIFIED SURVEY MAP

BEING ALL OF THE SE1/4 OF THE NE1/4 AND PART OF THE NE1/4 OF THE NE1/4 IN SECTION 15, T17N, R7E, TOWN OF LINCOLN, ADAMS, COUNTY, WISCONSIN.

DESCRIPTION:

Being all of the SE1/4 of the NE1/4 and part of the NE1/4 of the NE1/4 in Section 15, T17N, R7E, Town of Lincoln, Adams County, Wisconsin.

Beginning at the NE corner of said Section 15; thence along the east line of said NE1/4 bearing S00-25-27E, 2648.68 feet, to the E1/4 corner; thence along the south line of said SE1/4 bearing N89-55-15W, 1321.83 feet, to forty corner; thence along the west line of said forties bearing N00-22-21W, 2646.55 feet, to forty corner, being the centerline of CTH "M"; thence along the north line of said NE1/4 bearing N89-59-15E, 423.50 feet; thence bearing S01-18-57W, 301.78 feet; thence bearing S89-12-24E, 229.40 feet; thence bearing S01-53-49E, 142.95 feet; thence bearing N87-22-51E, 155.07 feet; thence bearing N00-00-48W, 212.68 feet; thence bearing N89-53-47E, 45.98 feet; thence bearing N01-08-55E, 14.89 feet; thence bearing N89-58-24E, 434.65 feet; thence bearing N00-00-45W, 213.00 feet, to said north line said centerline; thence along said north line said centerline bearing N89-59-15E, 33.00 feet, to the point of beginning, containing 3,254,144 s.f. or 74.70 gross acres.

Lot 2 of this mapping is subject to highway easement for CTH "M" being the northerly 33 feet thereof as shown and all other easements of record.
