

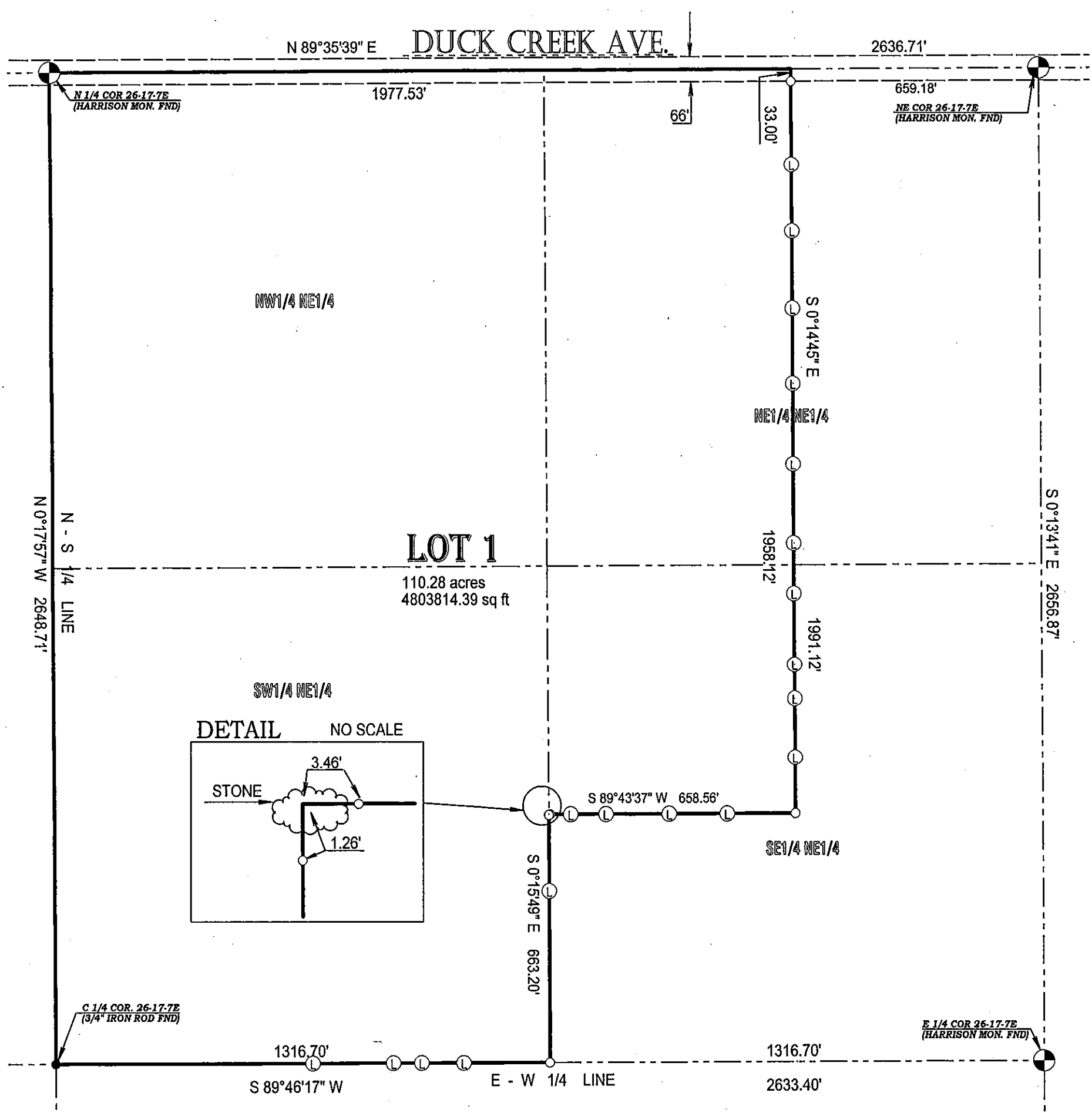

Being all of the NW1/4 NE1/4 and all of the SW1/4 NE1/4 and part of the NE1/4 NE1/4 and part of the SE1/4 NE1/4 of Section 26, Township 17 North, Range 7 East, Town of Lincoln, Adams County, Wisconsin, bounded and described as follows;

Commencing at the N1/4 COR. 26-17-7E, said point being the POINT OF BEGINNING;
 Thence N 89°35'39" E, a distance of 1977.53';
 Thence S 0°14'45" E, a distance of 1991.12' to an iron monument;
 Thence S 89°43'37" W, a distance of 658.56' to an iron monument;
 Thence S 0°15'49" E, a distance of 663.20' to an iron monument;
 Thence S 89°46'17" W, a distance of 1316.70' to an iron monument;
 Thence N 0°17'57" W, a distance of 2648.71' to an iron monument being the POINT OF BEGINNING; subject to right-of-ways, easements, restrictions and reservations of record, IF ANY.

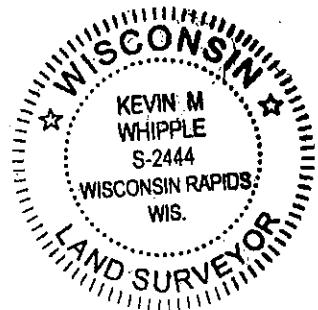

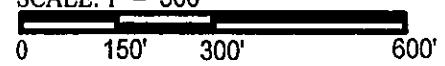
