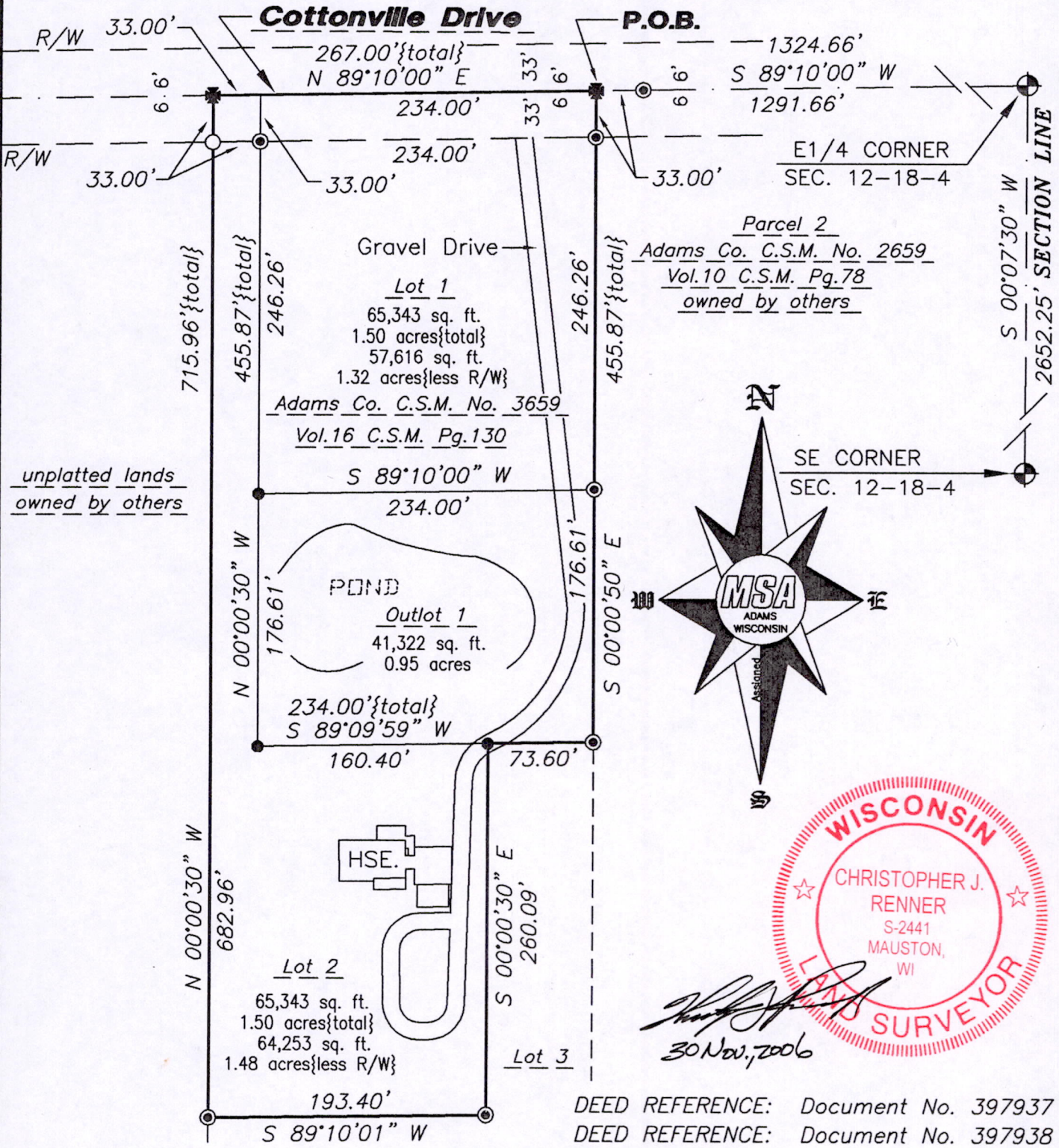

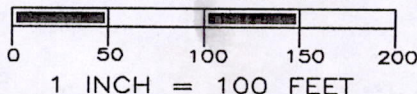


The East line of the Southeast Quarter of Section 12, T18N, R4E was assigned a bearing of S 00°07'30" W as the basis of bearings on this plat.


