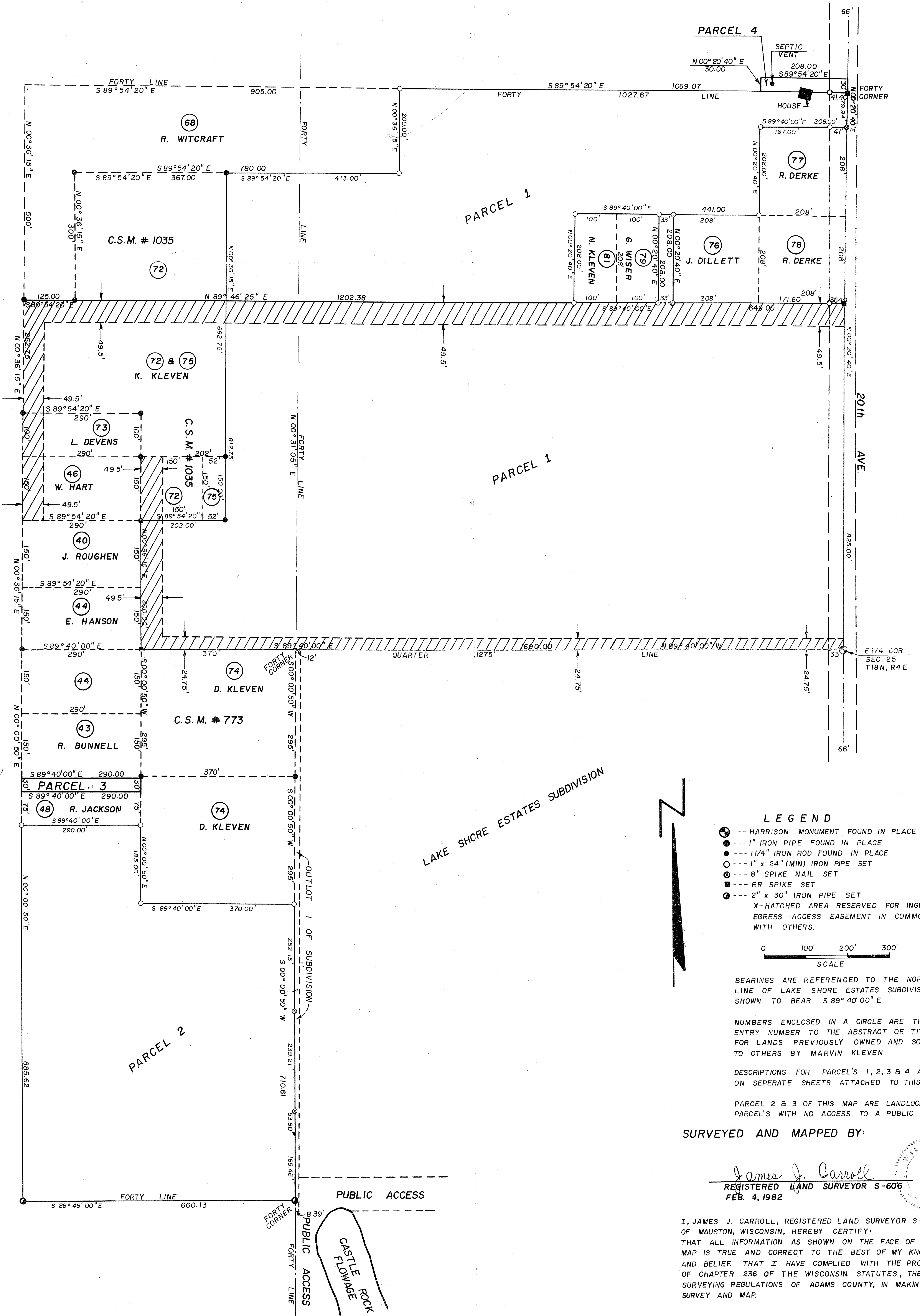

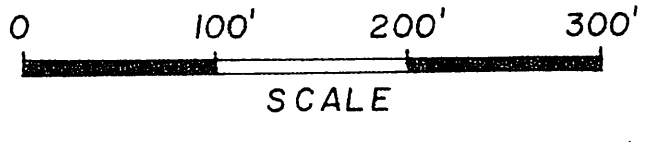
(MARVIN KLEVEN ESTATE MAP)

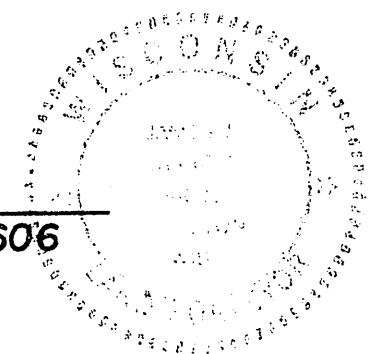
