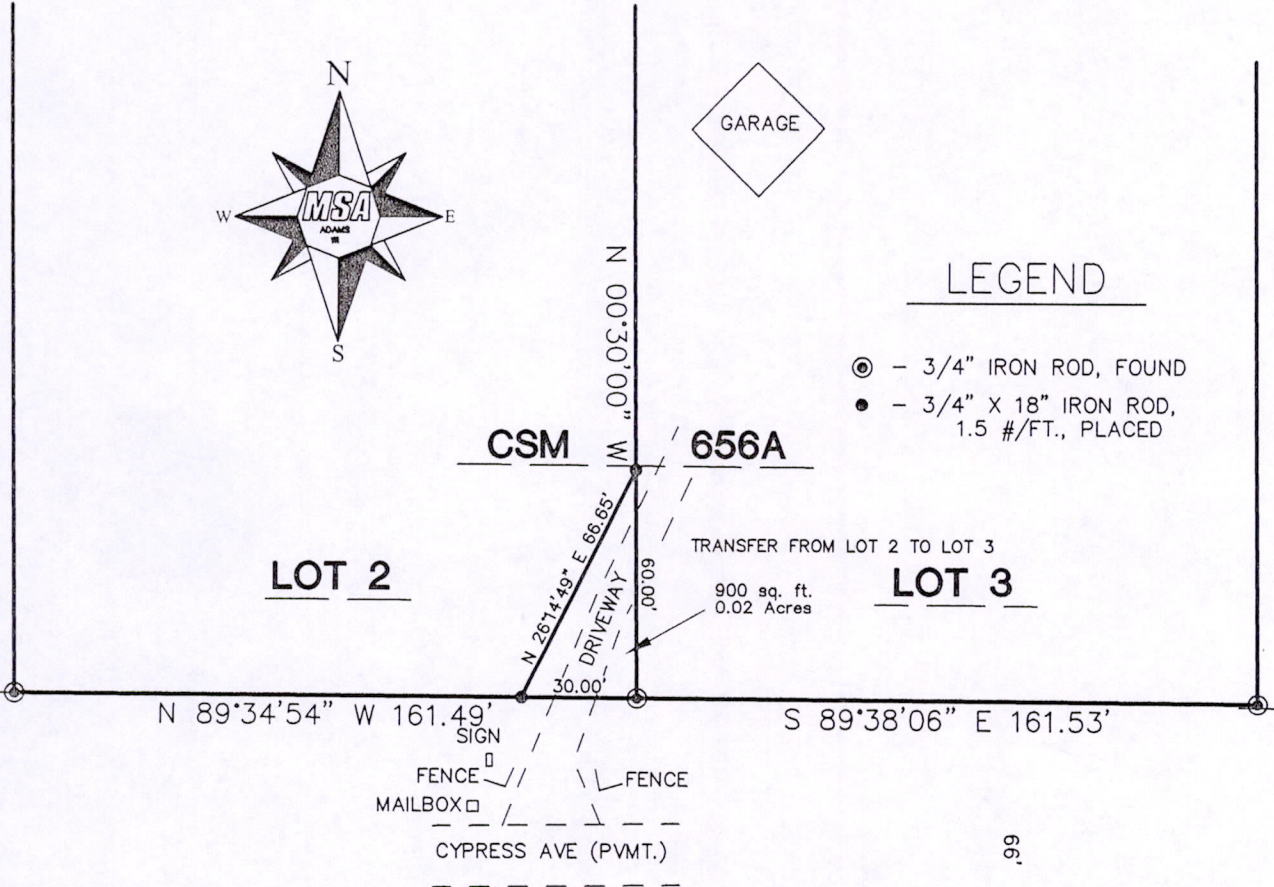

PLAT OF SURVEY

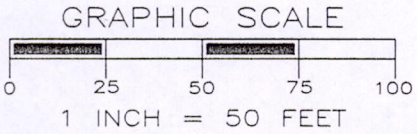
