

## SURVEYOR'S CERTIFICATE

I, Patrick A. Carroll, Registered Land Surveyor S-1199 for Carroll Surveying of Mauston, Wisconsin, hereby certify:

That in compliance with the provisions of Chapter 236.34 of the Wisconsin Statutes and Chapter AE-7 of the Administrative Code of the State of Wisconsin and Adams County Land Division Ordinance and under the direction od DENNIS PATTEN, owner of said land, I did survey and map a part of the  $NW\frac{1}{4}$  of the  $SW\frac{1}{4}$  in Section 24, T18N, R5E, in the Town of Strongs Prairie, Adams County, Wisconsin. That such map correctly represents the exterior boundaries and the subdivision of the land surveyed and mapped to the best of my knowledge and belief.

Thence along a line bearing S 89°49'00" E, 408.00 feet; thence bearing S 00°30'00" E, 534.00 feet, to a point in the north line of C.S.M. #5204; thence along the north line thereof bearing N 89°49'00 W, 408.00 feet, to the NW corner of said C.S.M. #5204, being a point in the west line of the said  $NW^{\frac{1}{4}}$  of the  $SW^{\frac{1}{4}}$ ; thence along the west line thereof bearing N 00°30'00" W, 534.00 feet, to the point of beginning, containing 217,857 SQ. FT. in area or 5.00 acres.
