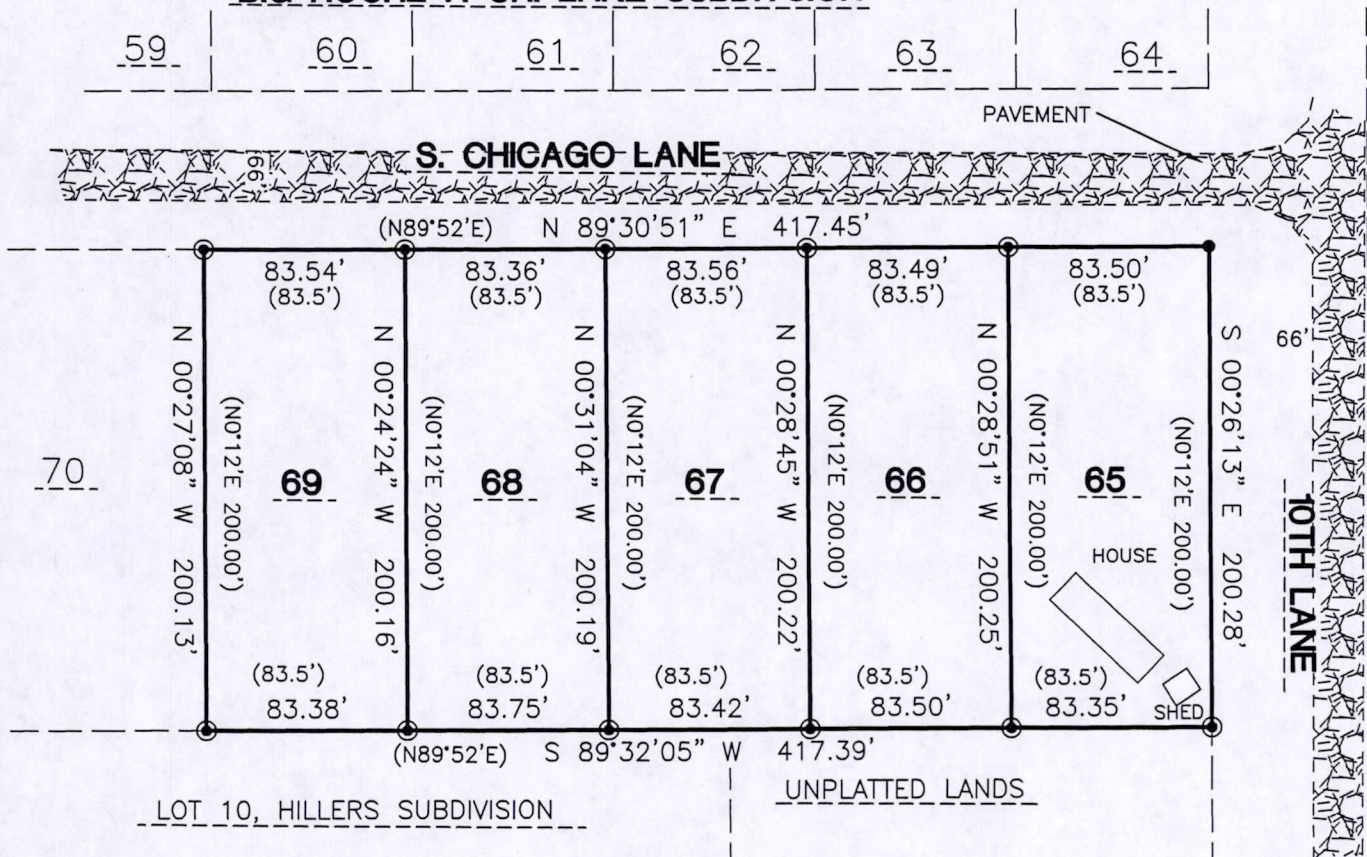

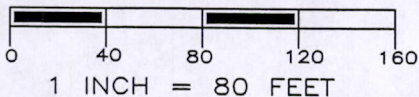

DESCRIPTION

Part of the Southwest Quarter of the Northwest Quarter of Section 4, Township 18 North, Range 6 East, Town of Preston, Adams County, Wisconsin, bounded and described as follows:

Commencing at the North Quarter corner of said Section 4; thence S89°55'35"W along the north line of the Northwest Quarter a distance of 1365.73 feet; thence S00°50'34"E a distance of 1403.80 feet to the Northeast corner of Southwest Quarter of the Northwest Quarter of said Section 4 and being the Point of Beginning. Thence continuing S00°50'34"E along the east line of the Southwest Quarter of the Northwest Quarter of said Section 4 a distance of 65.95 feet to the Northeast corner of Lot 1 of Adams County Certified Survey Map No. 3868; thence S89°08'55"W along the north line of said Lot 1 of Adams County Certified Survey Map No. 3868 a distance of 857.96 feet to the meander line of Big Roche-A-Cri Lake; thence N15°08'31"E along the meander line of Big Roche-A-Cri Lake a distance of 67.96 feet to the north line of the Southwest Quarter of the Northwest Quarter; thence N89°06'23"E along the north line of the Southwest Quarter of the Northwest Quarter a distance of 839.24 feet to the Point of Beginning.

Containing 57,849 Square Feet (1.328 Acres) and being subject to any and all covenants, restrictions, easements and right of ways of record
