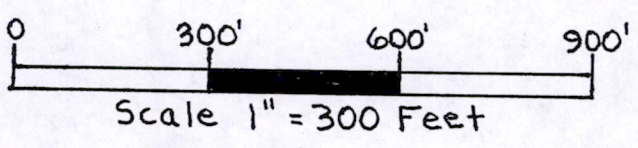
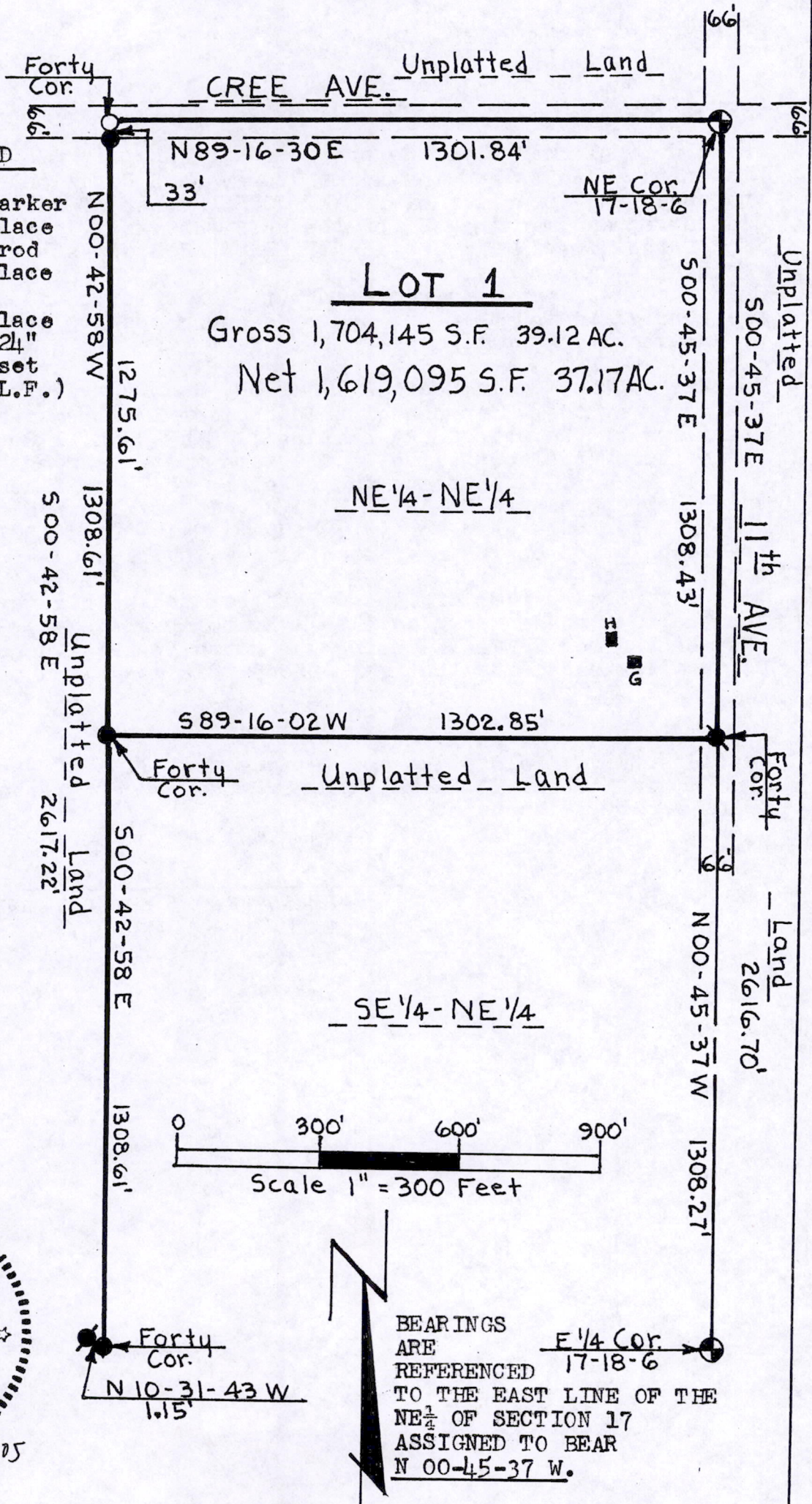

SURVEYOR'S CERTIFICATE

I, Patrick A. Carroll, Registered Land Surveyor S-1199 for Carroll Surveying of Mauston, Wisconsin, hereby certify:

That in compliance with the provisions of Chapter 236.34 of the Wisconsin Statutes and the Adams County Land Division Ordinance, and under the direction of MELVIN JONES, owner of said land, I did survey and map the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$; the west line of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$; all in Section 17, T18N, R6E, in the Town of Preston, Adams County, Wisconsin.

That such map correctly represents the exterior boundaries and the subdivision of the land surveyed and mapped to the best of my knowledge and belief.

The NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ in Section 17, T18N, R6E, to-wit:
Beginning at the NE corner of said Section 17; thence along the east line of the said forty bearing S 00-45-37 E, 1308.43 feet; thence along the south line of the said forty bearing S 89-16-02 W, 1302.85 feet; thence along the west line of the said forty bearing N 00-42-58 W, 1308.61 feet; thence along the north line of the said forty bearing N 89-16-30 E, 1301.84 feet, to the point of beginning, containing 1,704,145 SQ. FT. in area or 39.12 acres.

This described parcel of land is subject to the highway easements for the town roads known as 11th AVE. being the east 33 feet thereof and for CREE AVE. being the north 33 feet thereof and to all utility easements that may affect this described parcel of land.
