

SURVEYOR'S CERTIFICATE

I, Patrick A. Carroll, Registered Land Surveyor S-1199 for Carroll Surveying of Mauston, Wisconsin, hereby certify:

That in compliance with the provisions of Chapter 236.34 of the Wisconsin Statutes and Chapter AE-7 of the Administrative Code of the State of Wisconsin and the subdivision regulations of Adams County, and under the direction of DENNIS PATTEN, owner of said land, I did survey, divide and map Lot 7 of Adams County Certified Survey Map #2479 recorded in Vol. 9 at Page 160 being a part of the $NW^{\frac{1}{4}}$ of the $SE^{\frac{1}{4}}$ in Section 18, T18N, R6E, in the Town of Preston, Adams County, Wisconsin.

That such map correctly represents the exterior boundaries and the subdivision of the land surveyed and mapped to the best of my knowledge and belief.

Thence continued along the north-south quarter line bearing N 00-43-30 W, 328.69 feet; thence along a line bearing S 89-53-30 E 1317.34 feet, to a point in the east line of the said $NW_4^{\frac{1}{4}}$ of the $SE_4^{\frac{1}{4}}$; thence along the east line thereof bearing S 00-47-30 W, 327.93 feet; thence along a line bearing N 89-55-30 W, 1317.71 feet, to the point of beginning.
