

Commencing at the SW corner of said Section 36; thence along the south line of said SW1/4 in Section 36 bearing N89-26-26E, 659.71 feet, to the point of beginning. Thence along the ½ forty line bearing N00-43-27E, 43.31 feet; thence bearing S00-43-27W, 43.31 feet; thence continued along said south line bearing N89-26-26E, 66.00 feet; thence bearing N00-43-27E, 223.00 feet; thence bearing N89-26-26E, 1912.20 feet; thence bearing N89-26-13E, 660.12 feet, to ½ forty line; thence along said ½ forty line bearing N00-35-16E, 936.06 feet; thence along the arc of curve to the left, its chord bearing N00-35-16E, 809.75 feet; thence continued along said ½ forty line bearing N00-35-16E, 675.33 feet, to forty line; thence along said forty line bearing S88-43-33W, 664.82 feet, to center of section; thence along the forty line bearing N00-28-53E, 145.94 feet; thence along the arc of a curve to the left, its chord bearing N64-33-22W, 140.97 feet, to the point of termination.
