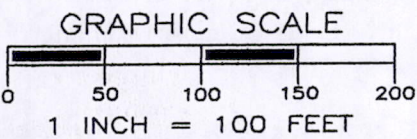
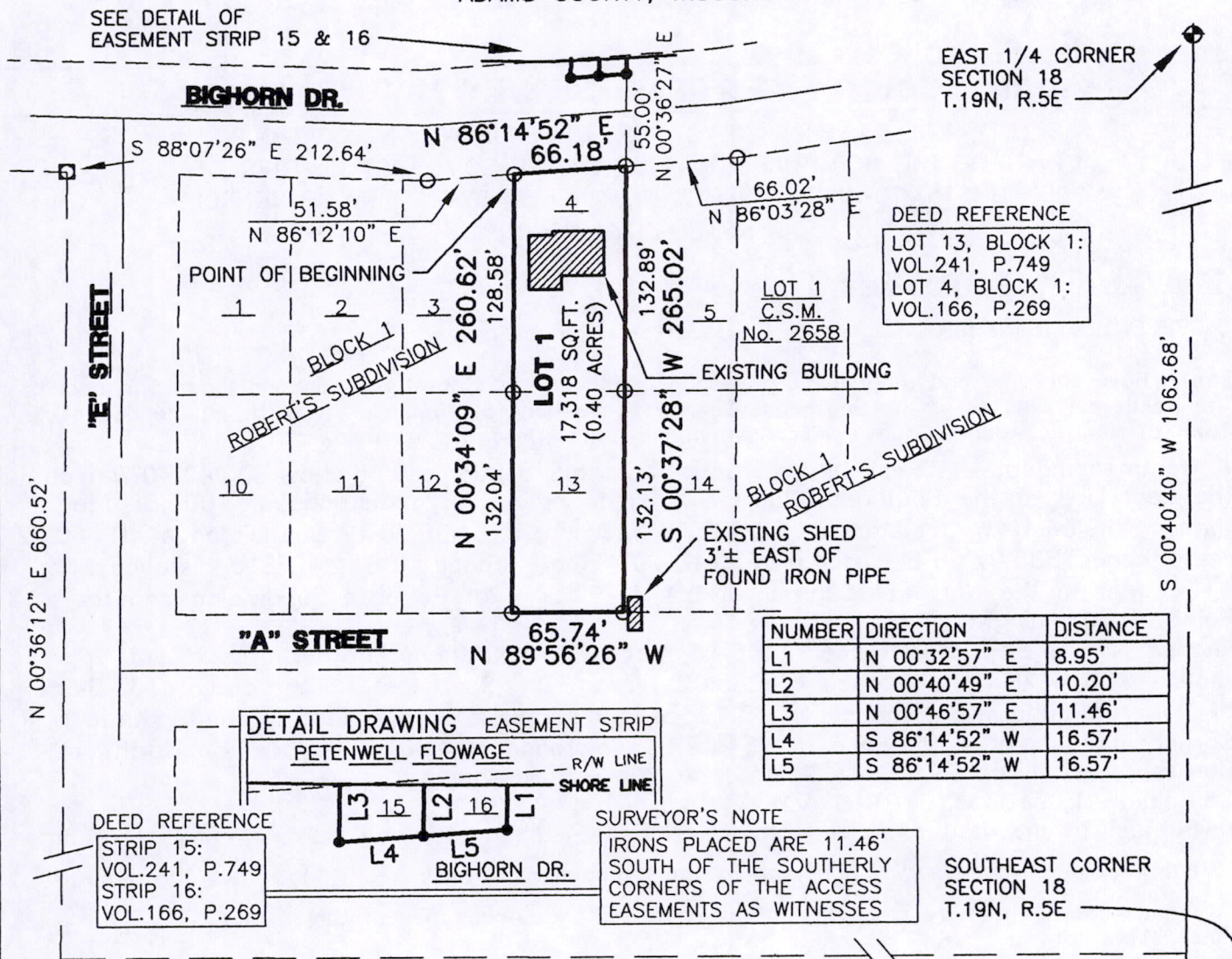

ADAMS COUNTY CERTIFIED SURVEY MAP

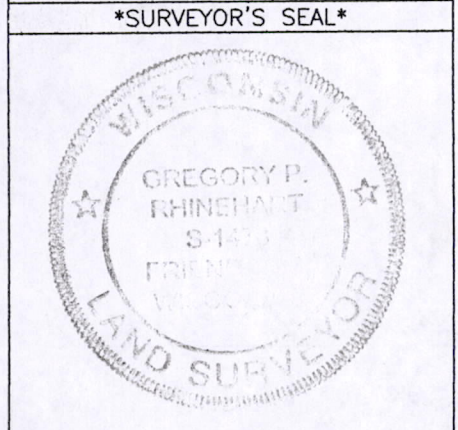

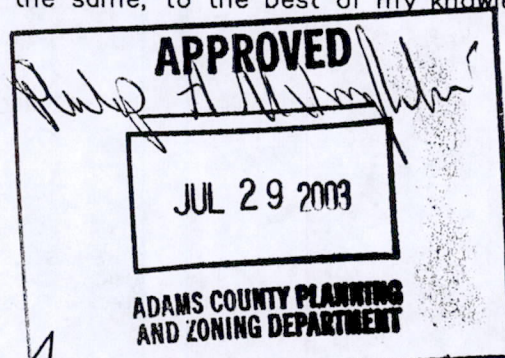
