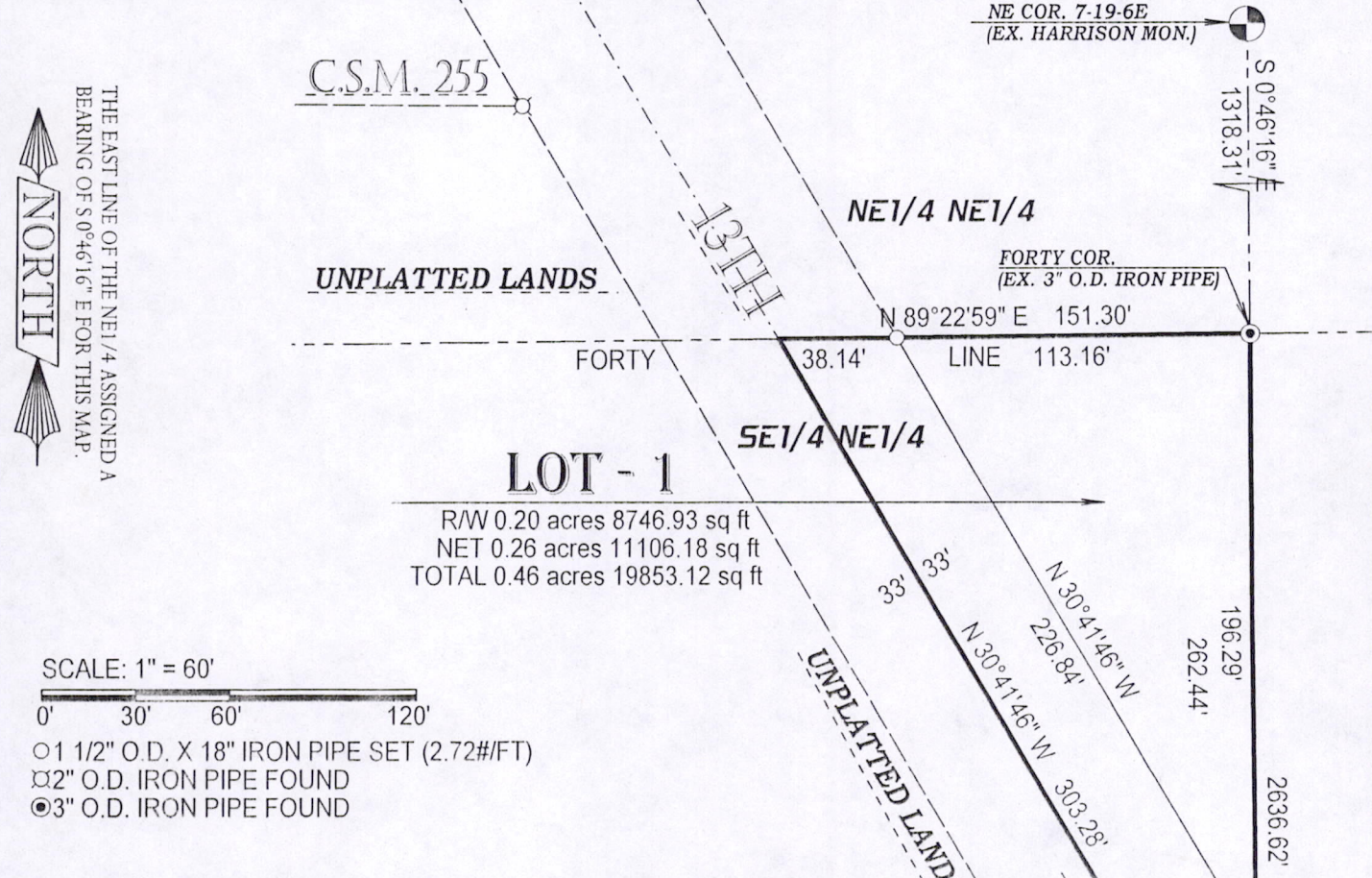

 Thence along the East Line of the NE1/4 a bearing of S 0°46'16" E, a distance of 1318.31' to an iron monument being the POINT OF BEGINNING;
 Thence continuing along said East Line of the NE1/4 a bearing of S 0°46'16" E, a distance of 196.29' to an iron monument;
 Thence continuing along said East Line of the NE1/4 a bearing of S 0°46'16" E, a distance of 66.15';
 Thence along the Centerline of 13th AVE a bearing of N 30°41'46" W, a distance of 303.28';
 Thence along the North Line of the SE1/4 NE1/4 a bearing of N 89°22'59" E, a distance of 38.14' to an iron monument;
 Thence continuing along said North Line of the SE1/4 NE1/4 a bearing of N 89°22'59" E, a distance of 113.16' to an iron monument being the POINT OF BEGINNING; subject to right-of-ways, easements, restrictions and reservations of record, IF ANY.

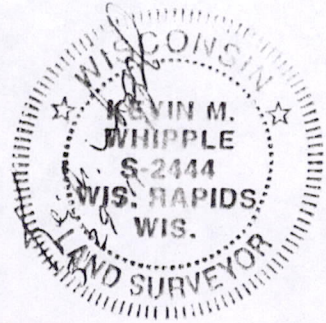
