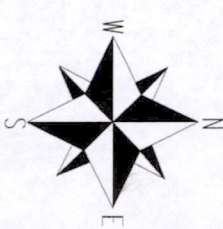

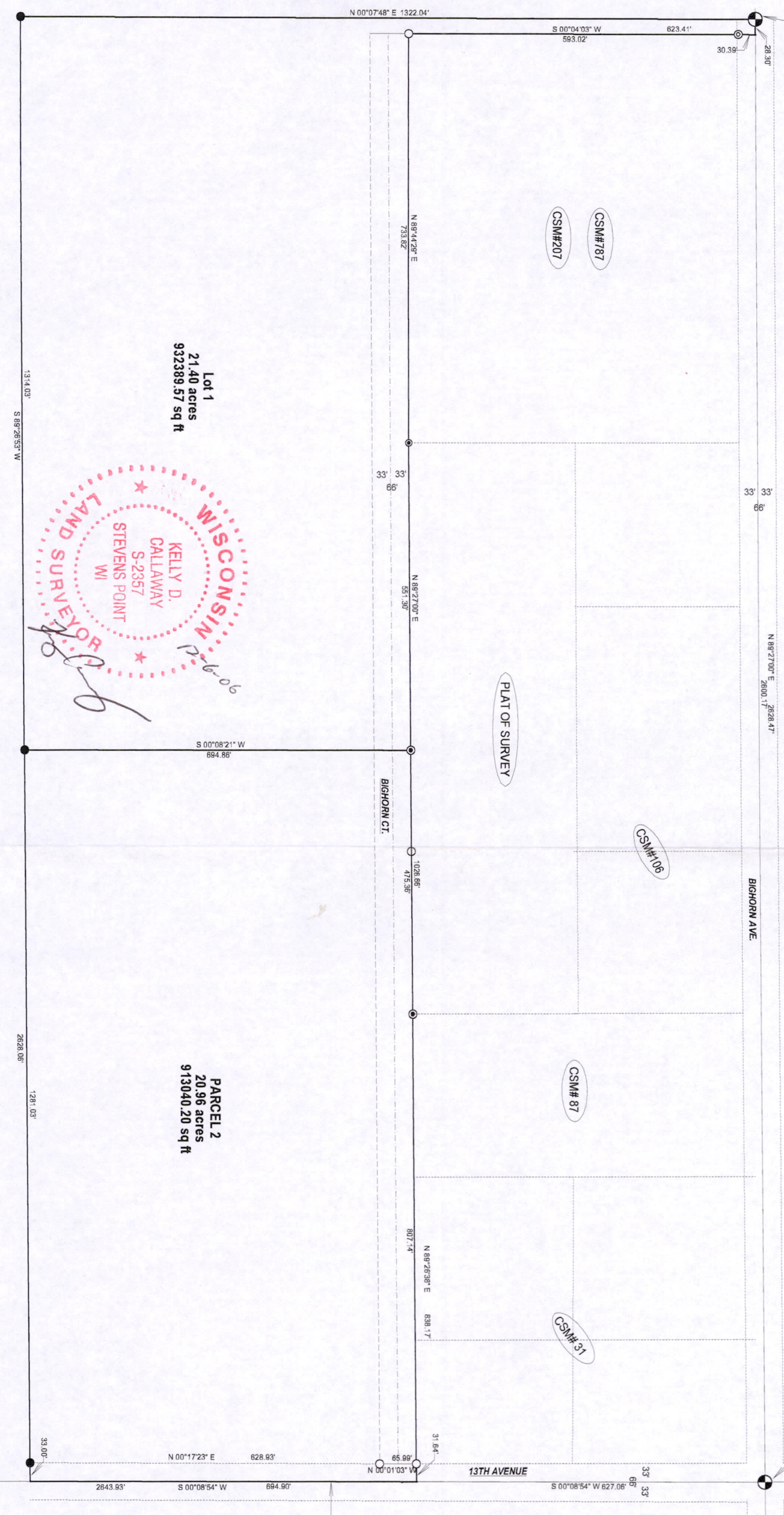

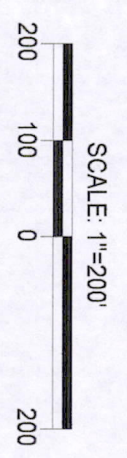

PARCEL 1 DESCRIPTION

A parcel of land located in the Northwest 1/4 of the Northeast 1/4 (NW1/4-NE1/4) of Section 18, T19N-R6E, Town of Big Flats, Adams County, Wisconsin. Described as follows:

Beginning at the North Quarter (N 1/4) corner of Section 18; thence N89°27'00"E, along the North line of the Northeast 1/4, 28.30 feet; thence S00°04'03"W, 623.41 feet to the North line of a Bighorn Court; thence N89°44'29"E, along said North line, 733.82 feet; thence N89°27'00"E, along said North line, 551.30 feet; thence S00°08'21"W, along the East line of the NW1/4-NE1/4, 694.86 feet; thence S89°26'53"W, along the South line of the NW1/4-NE1/4, 1314.03 feet; thence N00°07'48"E, along the West line of the NW1/4-NE1/4, 1322.04 feet to the point of beginning.

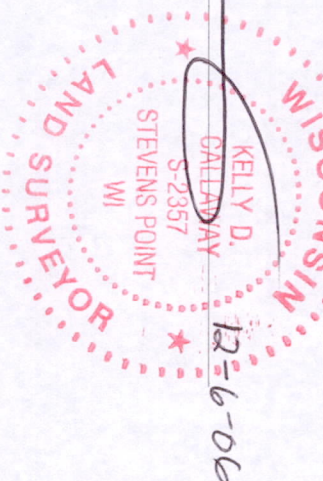
