

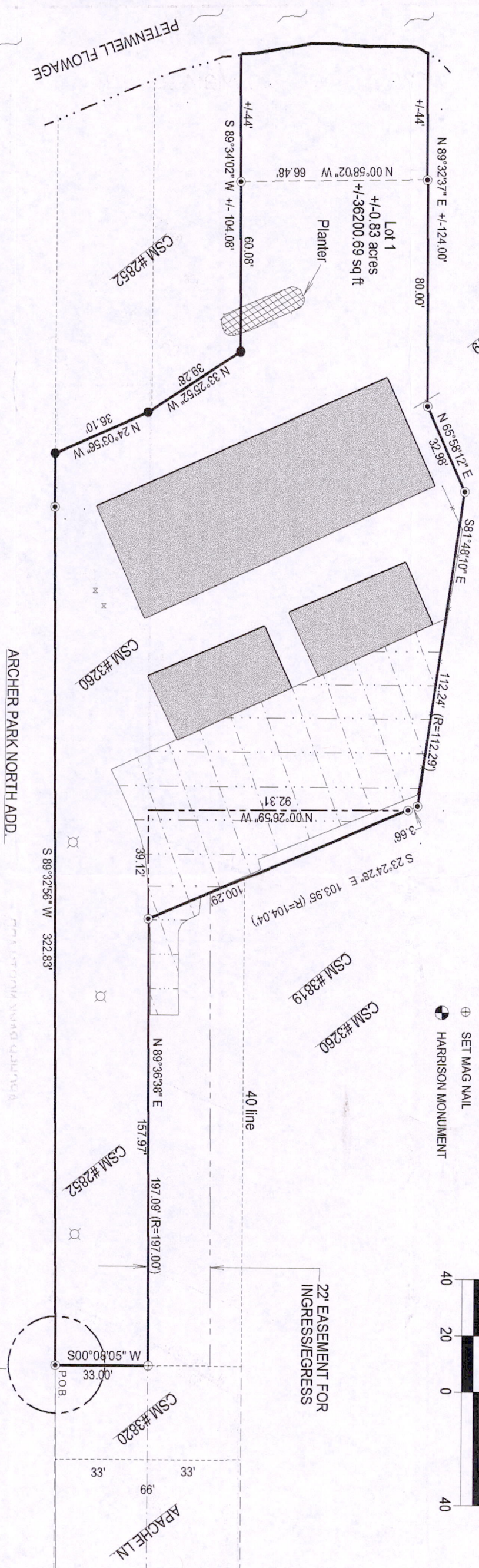
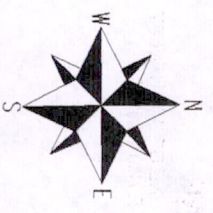
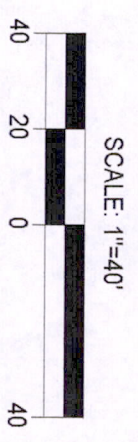
PLAT OF SURVEY MAP

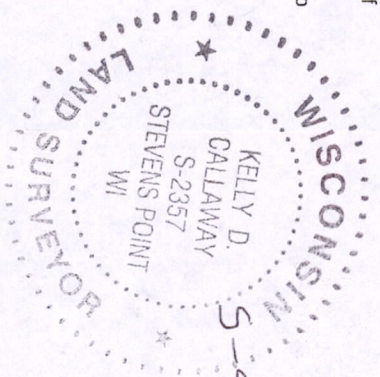

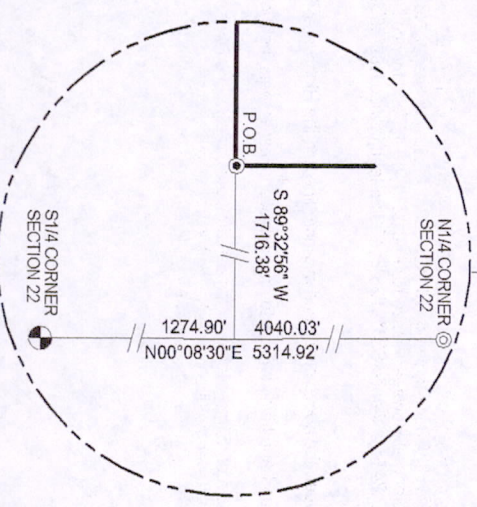
